1 Section 1. Section 28E.8, Code 1995, is amended to read as

3 28E.8 FILING AND RECORDING.

4 Before entry into force, an agreement made pursuant to this  
5 chapter shall be filed with the secretary of state and  
6 recorded with the county recorder. In counties in which the  
7 office of county recorder is abolished, the agreement shall be  
8 recorded with the county auditor.

9 EXPLANATION

10 This bill provides that intergovernmental agreements for  
11 the joint exercise of governmental power, commonly known as  
12 chapter 28E agreements, shall be filed in the county auditor's  
13 office in those counties in which the office of the county  
14 recorder has been abolished.
