A BILL FOR

1 An Act requiring, for purposes of ratemaking, the allocation of  
2 pregnancy-related health expenses equally among female and  
3 male policyholders, subscribers, or enrollees of individual  
4 third-party payor medical expense contracts.

1 Section 1. NEW SECTION. 514C.13 ALLOCATION OF PREGNANCY-  
2 RELATED EXPENSES AMONG INSURED OR COVERED INDIVIDUALS.

3 1. A third-party payor offering a policy or contract  
4 providing for third-party payment or prepayment of health or  
5 medical expenses on an individual or nongroup basis shall, for  
6 ratemaking purposes, allocate maternity, pregnancy, and  
7 childbirth-related expenses equally between female and male  
8 subscribers, policyholders, or enrollees of all such policies  
9 and contracts, regardless if a class of policy or contract  
10 purports to exclude coverage for such benefits for a male, or  
11 if policies or contracts written for females are materially  
12 different from those written for males. A contract or policy  
13 for Medicare supplemental benefits may exclude expenses  
14 related to maternity, pregnancy, and childbirth for both males  
15 and females, and a Medicare supplemental policy shall not have  
16 such expenses allocated against it.

17 2. For purposes of this section, "third-party payor"  
18 includes, but is not limited to, the following:

19 a. A person offering individual accident and sickness  
20 coverage on an expense-incurred basis.

21 b. A person offering an individual hospital or medical  
22 service contract issued pursuant to chapter 514.

23 c. A person offering an individual health maintenance  
24 organization contract regulated under chapter 514B.

25 EXPLANATION

26 This bill would require that expenses related to maternity,  
27 pregnancy, and childbirth paid by a third-party payor be  
28 allocated equally to individual or nongroup female and male  
29 policyholders, subscribers, or enrollees for purposes of  
30 ratemaking. Medicare supplemental policies are permitted to  
31 exclude such benefits from the scope of coverage and shall not  
32 have maternity, pregnancy, and childbirth expenses allocated  
33 against them.
