A BILL FOR

1 An Act relating to and making appropriations to the department of
2 elder affairs for aging programs and services, and the Iowa
3 department of public health for the public health nursing
4 program, the home care aide program, and the Iowa senior
5 health program.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. NEW SECTION. 135.12 COUNTY PROGRAM
2 APPROPRIATIONS.

3 1. There is appropriated from the general fund of the
4 state to the Iowa department of public health for the public
5 health nursing program and the homemaker-home health aide
6 program, pursuant to section 135.11, subsection 15, and the
7 Iowa senior health program as established by rule, for the
8 fiscal year beginning July 1, 1998, and each succeeding fiscal
9 year, twelve million four hundred fifty-four thousand eight
10 hundred fifty-four dollars.

11 The moneys shall be allocated as follows:

12 a. Two million six hundred thirty-seven thousand four
13 hundred sixty-five dollars shall be allocated to the county
14 public health nursing program. Funds allocated in excess of
15 amounts appropriated for the fiscal year beginning July 1,
16 1998, and ending June 30, 1999, shall be allocated for home
17 nursing visits for the elderly programs.

18 b. Nine million sixteen thousand fifty-two dollars to the
19 home care aide program. Funds allocated in excess of amounts
20 appropriated for the fiscal year beginning July 1, 1998, and
21 ending June 30, 1999, shall be allocated for homemaker-home
22 health and chore program services for the elderly.

23 c. Eight hundred one thousand three hundred thirty-seven
24 dollars for the Iowa senior health program.

25 2. All funds appropriated to counties pursuant to this
26 section in excess of amounts appropriated for the fiscal year
27 beginning July 1, 1989, and ending June 30, 1990, shall not be
28 reduced for administrative expenses or allocated for the
29 development of new program initiatives other than initiatives
30 developed locally through a county organization planning
31 process.

32 Sec. 2. NEW SECTION. 231.56A ELDERLY SERVICES --
33 APPROPRIATION.

34 1. There is appropriated from the general fund of the
35 state to the department of elder affairs for the elderly

1 services program established in section 231.56, for the fiscal
2 year beginning July 1, 1998, and each succeeding fiscal year,
3 four million four hundred thousand four hundred eight dollars.

4 The moneys shall be allocated as follows:

5 a. Two hundred fifteen thousand dollars shall be allocated
6 to the retired senior volunteer program.

7 b. One hundred fifteen thousand dollars shall be allocated
8 to the Iowa chapters of the Alzheimer's association.

9 c. Twenty five thousand dollars to the mental health
10 outreach program.

11 d. Two million five hundred thousand dollars to the case
12 management for frail elders program.

13 e. Three hundred fifty thousand dollars for adult day care
14 services.

15 f. One million one hundred ninety-five thousand four
16 hundred eight dollars for additional elderly services programs
17 not specifically enumerated in this section which are approved
18 by an area agency on aging for provision of the service within
19 an area.

20 2. All funds allocated to the area agencies on aging for
21 elderly services programs, in excess of amounts appropriated
22 for the fiscal year beginning July 1, 1989, and ending June
23 30, 1990, shall not be reduced for administrative expenses or
24 allocated for the development of new program initiatives other
25 than initiatives developed through the area planning process
26 pursuant to section 231.33, subsection 1.

27 EXPLANATION

28 This bill provides for standing appropriations to the
29 department of elder affairs for aging programs and services
30 and to the Iowa department of public health for the public
31 health nursing program, the homemaker-home health aide
32 program, and the Iowa senior health program, for the fiscal
33 year beginning July 1, 1998, and each succeeding fiscal year.
34 With respect to appropriations to the department of elder
35 affairs, the bill provides that funding for elderly services

1 programs, in excess of amounts appropriated for the fiscal
2 year beginning July 1, 1989, and ending June 30, 1990, shall
3 not be reduced for administrative expenses or allocated for
4 the development of new program initiatives other than
5 initiatives developed through the area planning process.
6 Regarding appropriations to the Iowa department of public
7 health, the bill provides that the appropriated funds to
8 counties in the bill in excess of amounts appropriated for the
9 fiscal year beginning July 1, 1989, and ending June 30, 1990,
10 shall not be reduced for administrative expenses or allocated
11 for the development of new program initiatives other than
12 initiatives developed locally through a county organization
13 planning process.

AN ACT

RELATING TO THE ISSUANCE OF HIGHWAY TRAVEL PERMITS TO RAW MILK TRANSPORTERS WHOSE MOTOR TRUCKS EXCEED GROSS WEIGHT AND AXLE WEIGHT RESTRICTIONS AND ESTABLISHING A PER.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. NEW SECTION. 321E.29A RAW MILK TRANSPORTERS.

The department or a local authority may issue annual permits authorizing a raw milk transporter to transport by motor truck raw milk to or from a milk plant, receiving station, or transfer station. The combined gross weight or gross weight on any axle or groups of axles of the motor truck shall not exceed the limits established under section 321.463. The issuing authority may specify weight limits or routes for each raw milk transporter or establish weight limits or routes under section 321E.8.

Sec. 2. Section 321.463, subsection 3, Code Supplement 1997, is amended to read as follows:

3. Notwithstanding other provisions of this chapter to the contrary, indivisible loads operating under the permit requirements of sections 321E.7, 321E.8, and 321E.9, and
