1 Section 1. Section 24.9, unnumbered paragraph 1, Code  
2 Supplement 1997, is amended to read as follows:  
3 Each municipality shall file with the secretary or clerk  
4 thereof of the municipality the estimates required to be made  
5 in sections 24.3 to 24.3, at least twenty days before the date  
6 fixed by law for certifying the same to the levying board and  
7 shall ~~forthwith~~ fix a date for a hearing on the  
8 estimates, and shall publish on forms prescribed by the  
9 department of management such estimates and any annual levies  
10 previously authorized as provided in section 76.2, with a  
11 notice of the time when and the place where such hearing shall  
12 be held not less than ten nor more than twenty days before the  
13 hearing. ~~Provided-that-in~~ in municipalities of less than two  
14 hundred population such the estimates and the notice of  
15 hearing thereon on the estimates shall be posted in three
