Over the course of the next 154 years, changes have been made, but the core of public health has been to reduce the impact of disease on the residents of Iowa. The Centers for Disease Controls (CDCs) definition: Public health is the science of protecting and improving the health of people and their communities. This work is achieved by promoting healthy lifestyles, researching disease and injury prevention, and detecting, preventing and responding to infectious diseases. Introducing a personal belief school exemption and allowing parents to refuse vaccines for nonmedical reasons not only endangers their own children, but other, more vulnerable children in the school.

Similarly, hospital patients should not have to worry about catching these diseases from staff because the government prohibits a hospital from requiring essential vaccines for their workers. Employers, especially those in healthcare, have the responsibility to ensure a safe workplace, and should not be prohibited from requiring wellestablished disease prevention measures like immunizations, when the situation is appropriate. Of course, medical exemptions are available when vaccines are truly contraindicated. But refusing basic public health standards for any other reason is a choice, and choices are not without consequences when they endanger other people and infringe upon their right to safety. If SF193 would pass, it would put students, patients, and everybody at increased risk of dangerous disease.

Vaccination rates in Iowa have been declining for some time now and we are at a critical point. Measles is over FIVE TIMES AS CONTAGIOUS as COVID. One or two out of every thousand people infected with measles dies. Unfortunately, many children are medically unable to receive the vaccine. to vaccinate their children. Researchers now link falling immunization rates to recent resurgences of vaccinepreventable diseases. In 2010, California saw 9,120 cases of whooping cough, more than any year since the whooping cough vaccine was introduced in the 1940s. Ten infants too young to be vaccinated died of whooping cough during the outbreak. The CDC warns that events like these will become more frequent and harder to control if vaccination rates continue to fall. Fears over the safety of vaccines are understandable. The CDC vaccination schedule calls for children to receive up to 14 inoculations by the age of six many of them vaccines developed within the last twenty years. Many parents distrust these vaccines; worried about the potential for risks and longterm side effects. Research, however, shows that most of our biggest fears about vaccinations are unfounded. These eight major vaccine myths that research has shown to be baseless: Myth #1: Vaccines cause autism. The widespread fear that vaccines increase risk of autism originated with a 1997 study published by Andrew Wakefield, a British surgeon. The article was published in The Lancet, a prestigious medical journal, suggesting that the measles, mumps, rubella (MMR) vaccine was increasing autism in British children. The paper has since been completely discredited due to serious procedural errors, undisclosed financial conflicts of interest, and ethical violations. Andrew Wakefield lost his medical license and the paper was retracted from The Lancet. Nonetheless, the hypothesis was taken seriously, and several other major studies were conducted. And even more recent research provides evidence that autism develops in utero, well before a baby is born or receives vaccinations. Myth #2: Infant immune systems can't handle so many vaccines. Infant immune systems are stronger than you might think. Based on the number of antibodies present in the blood, a baby would theoretically have the ability to respond to around 10,000 vaccines at one time. Even if all 14 scheduled vaccines were given at once, it would only use up slightly more than 0.1% of a baby's immune capacity. And scientists believe this capacity is purely theoretical. The immune system could never truly be overwhelmed because the cells in the system are constantly being replenished. In reality, babies are exposed to countless bacteria and viruses every day, and immunizations are negligible in comparison. Though there are more vaccinations than ever before, today's vaccines are far more efficient. Small children are actually exposed to fewer immunologic components overall than children in past decades. Myth #3: Natural immunity is better than vaccineacquired immunity. In some cases, natural immunity meaning actually catching a disease and getting sick results in a stronger immunity to the disease than a vaccination. However, the dangers of this approach far outweigh the relative benefits. If you wanted to gain immunity to measles, for example, by contracting the disease, you would face a 1 in 500 chance of death from your symptoms. In contrast, the number of people who have had severe allergic reactions from an MMR vaccine, is less than one in one million. Myth #4: Vaccines contain unsafe toxins. People have concerns over the use of formaldehyde, mercury or aluminum in vaccines. It's true that these chemicals are toxic to the human body in certain levels, but only trace amounts of these chemicals are used in FDA approved vaccines. In fact, according to the FDA and the CDC, formaldehyde is produced at higher rates by our own metabolic systems and there is no scientific evidence that the

low levels of this chemical, mercury or aluminum in vaccines can be harmful. See section III of this guide to review safety information about these chemicals and how they are used in vaccines. Myth #5: Better hygiene and sanitation are actually responsible for decreased infections, not vaccines. Vaccines don't deserve all the credit for reducing or eliminating rates of infectious disease. Better sanitation, nutrition, and the development of antibiotics helped a lot too. But when these factors are isolated and rates of infectious disease are scrutinized, the role of vaccines cannot be denied. One example is measles in the United States. When the first measles vaccine was introduced in 1963, rates of infection had been holding steady at around 400,000 cases a year. And while hygienic habits and sanitation didn't change much over the following decade, the rate of measles infections dropped precipitously following the introduction of the vaccine, with only around 25,000 cases by 1970. Another example is Hib disease. According to CDC data, the incidence rate for this malady plummeted from 20,000 in 1990 to around 1,500 in 1993, following the introduction of the vaccine. Myth #6: Vaccines aren't worth the risk. Despite parent concerns, children have been successfully vaccinated for decades. In fact, there has never been a single credible study linking vaccines to long term health conditions. As for immediate danger from vaccines, in the form of allergic reactions or severe side effects, the incidence of death are so rare they can't even truly be calculated. For example, only one death was reported to the CDC between 1990 and 1992 that was attributable to a vaccine. The overall incidence rate of severe allergic reaction to vaccines is usually placed around one case for every one or two million injections. Myth #7: Vaccines can infect my child with the disease it's trying to prevent. Vaccines can cause mild symptoms resembling those of the disease they are protecting against. A common misconception is that these symptoms signal infection. In fact, in the small percentage (less than 1 in one million cases) where symptoms do occur, the vaccine recipients are experiencing a body's immune response to the vaccine, not the disease itself. There is only one recorded instance in which a vaccine was shown to cause disease. This was the Oral Polio Vaccine (OPV) which is no longer used in the U.S. Since then, vaccines have been in safe use for decades and follow strict Food and Drug Administration (FDA) regulations. Myth #8: We don't need to vaccinate because infection rates are already so low in the United States. Thanks to "herd immunity," so long as a large majority of people are immunized in any population, even the unimmunized minority will be protected. With so many people resistant, an infectious disease will never get a chance to establish itself and spread. This is important because there will always be a portion of the population infants, pregnant women, elderly, and those with weakened immune systems that can't receive vaccines. But if too many people don't vaccinate themselves or their children, they contribute to a collective danger, opening up opportunities for viruses and bacteria to establish themselves and spread. Not to mention, as the Centers for Disease Control (CDC) warn, international travel is growing quickly, so even if a disease is not a threat in your country, it may be common elsewhere. If someone were to carry in a disease from abroad, an unvaccinated individual will be at far greater risk of getting sick if he or she is exposed. Vaccines are one of the great pillars of modern medicine. Life used to be especially brutal for children before vaccines, with huge portions being felled by diseases like measles, smallpox, whooping cough, or rubella, to name just a few. Today these ailments can be completely prevented with a simple injection. I cared for the what I believe to have been the last case of paralytic wild type polio, in an unvaccinated child, at the University of Iowa during my residency in the 1970s. I have cared for children with devastating measles encephalitis that is now nearly 100% preventable. I have had the horror of caring for many patients with severe whooping cough, of watching whooping cough and mumps spread in unvaccinated cohorts of children unable speak for themselves, when parents who are uninformed about the safety and effectiveness of vaccines refused to have them immunized. The dangers of vaccine hesitancy accrue not to those who refuse vaccination but to their children, and more to the point, to your and my children who may not be medically able to be vaccinated and are completely dependent on herd immunity derived from high vaccination rates in the community. Sending unimmunized children into the community is like drunk driving. Both the intoxicated driver and innocent bystanders are placed at risk by irresponsible behavior. We are required to protect our children with seat belts, and vaccines are a form of seat belt. Those of us old enough to have seen polio and measles epidemics live with the terror that the antivaccine movement will return us to those days, based on ignorance and misplaced distrust of a manifestly safe set of interventions, the childhood vaccine schedule. As an advocate for scientific and data driven decisions, this past year has been less than that; it has shown us that uniformed or misinformed government or business decisions can occur, leaving citizens fighting for their basic rights for a virus, SARSCOV2, that has a 99.5% recovery rate (per CDCs data). In addition, the COVID19 vaccines being promoted, aka mRNA injections, are not FDA approved, and are only authorized for emergency use. The COVID19 vaccines make no claim of providing immunity nor do they inhibit the transmissibility of the disease. They are only designed to lessen symptoms if and when you get infected and this is from an illness that a person already has a 99.5% chance of recovery, and that percentage doesnt take into account the prescribed medications that can reduce or eliminate symptoms and assist with the recovery. Weve already seen discrimination and liberties violated due to requirements against this low infection fatality rate illness; whats around the corner if we dont provide legal guidelines now? In the short time that the COVID19 injections have occurred, as of February 5, 2021, 12,697 adverse reactions to the injections have been reported to VAERS with 653 of those as deaths along with 2792 urgent care visits. Although VAERS is an important tool in understanding vaccine adverse reactions, only a small percent of reactions are reported. If Iowas Director of Public Health, as recent as January, can promote incentivizing this type of experimental vaccinations to individuals hesitant to participate, what is to stop my employer, insurer, or medical provider, from also doing so? What incentive will they offer? Take it to keep my job, be insured, or receive medical care? Glimpses of this are already occurring. The natural immune system response that creates herd immunity for viral infections and often times to their viral counterparts, is being twisted to shame and pressure people into vaccinations when data has not shown that

vaccinations have made a significant impact on herd immunity. In the 1980s, the

CDC recommended about 24 vaccine doses up until age 18, but now the CDCs schedule contains 69 vaccines for birth to 18 years with almost half given before age 1, and still outbreaks occur in these vaccinated children. Are we seeing public health being impacted negatively by vaccines with autism, autoimmune reactions, and other diseases increasing? On the flip side, the positive impact weve seen with vaccines is the billions of dollars that are to be made in pharmaceuticals and the medical field from manufacturing to distribution, all at the expense of the citizen, financially and healthwise. Also, its hard to believe, with all the data we have, that there is a push for children to have an experimental vaccine injected into them. It has been proven children do not transmit this illness and close to 100% (99.997%) of them recover or do not show any symptoms at all. Dear Senator Carlin, Senator Costello, and Senator Jochum,

I am writing today on behalf of the Biotechnology Innovation Organization (BIO) to **oppose SF 193**.

BIO is a national trade association for the biotechnology industry, representing over 1,000 companies and academic institutions involved in the research and development of innovative healthcare, agriculture, industrial, and environmental biotechnology products. BIO members include companies working on vaccines and therapeutics to combat the COVID-19 pandemic. Our member companies are committed to rigorous science; the safety of our vaccine and therapeutics is our top priority.

Immunizations are a triumph of public health. Over the past century, high childhood immunization rates have led to millions of lives saved, cases of disease averted, and costs to the health care system saved. FDA approval and CDC recommendations for use of vaccines represent the gold standard; BIO therefore supports the use of vaccines according to FDA's and CDC's guidelines.

The COVID-19 pandemic has shown us the devastating effects of an infectious disease unchecked by a vaccine. Biopharmaceutical companies have worked tirelessly over the past year to find a vaccine to provide the longed-for end to the pandemic, the full opening up of the economy, and a return to everyday activities. While questions from the public about the safety, efficacy, and speed of the COVID-19 vaccine are legitimate



and should be addressed, policies that sow doubt in people's minds merely serve as an undue barrier to the end of the pandemic.

Additionally, as a secondary result of the pandemic, Iowa saw routine pediatric immunization rates drop by more than 20% over the past year. Nationally, immunization rates for adolescents and adults also fell by as much as 50%. As we return to our pre-pandemic routines, strong immunization rates are needed to avert outbreaks of other infectious diseases such as measles, pertussis, and influenza on top of COVID-19.

The state legislature should focus on policies that reflect the best scientific evidence to facilitate access to vaccines for those that want to be vaccinated rather than policies that discourage it, especially in the middle of a pandemic. Alternative vaccine policies may include:

- Educational communications or campaigns about the importance of vaccination, including remaining up-to-date on routine immunizations during the pandemic;
- Increasing funding for public health and the immunization infrastructure;
- Lowering Medicaid cost-sharing for vaccines, as Medicaid-enrolled and uninsured adults are the only population that has any cost-sharing requirements for vaccines;
- Improving the state immunization information system (IIS) to ensure interoperability and the ability of all immunizer to report into the system; and
- Expanding scope of practice for different provider types to ensure adults can get vaccines in their communities at their convenience.

BIO and our members welcome the opportunity to discuss strategies for facilitating vaccinations. Please do not hesitate to reach out if we can be a resource.
