Chair Baudler recognized Representative Klein for opening comments on HSB 49: A study bill for establishing a child endangerment offense for the mother of a newborn child who caused an illegal drug to be present in the newborn child's body, and providing a penalty. Representative Klein made opening comments. After discussion of HSB 49, Representative Klein made closing remarks. Representative Klein moved HSB 49. Those members voting aye: Chair Baudler; Vice Chair Shaw; Ranking Member Kressig; Representatives Brandenburg; Dawson; Fry; Heartsill; Huseman; Klein; Muhlbauer; S. Olson; Rayhons; Salmon; Sands; Worthan. Those members voting nay: Abdul-Samad; Anderson; Berry; Gaines; R. Olson; Wolfe. Having received an affirmative vote of a majority of the committee membership as required to report a bill out of committee, HSB 49 moved to the House Floor as a committee bill.

Chair Baudler recognized Representative Brandenburg for opening comments on HSB 54: A study bill relating to the possession of certain products with the intent to use the products to manufacture a controlled substance, and making penalties applicable. Representative Brandenburg made opening comments. As there was no discussion of HSB 54, Representative Brandenburg made closing remarks. Representative Brandenburg moved HSB 54. The bill was unanimously approved. Having received an affirmative vote of a majority of the committee membership as required to report a bill out of committee, HSB 54 moved to the House Floor as a committee bill.

As there was no additional business to come before the committee, Representative Olson, R. moved to adjourn. The committee was adjourned at 3:50 P.M.
