On February 12th at 1:00 p.m., an immediate House Judiciary meeting was scheduled in Room 102 with the purpose of assigning bills and HSB 8, 12, 31, 34, and 37.

Both parties caucused from 1:00 - 1:15.

Chairperson Baltimore assigned the following bills:

HSB 100 - Garrett CH, Alons, Dawson  
HSB 121 - Heartsill CH, Windschitl, Wolfe

The following bills were considered:

HSB 8 - Chairperson Baltimore introduced Representative Gassman for opening comments. With no further comments, HSB 8 was moved to a vote. After a vote of 21 (y) - 0 (n) HSB 8 will move to the House Floor as a committee bill.

HSB 12 - Chairperson Baltimore recognized Representative Garrett for opening comments regarding HSB 12. After discussion a vote was taken and HSB 12 moved to the House Floor with the majority vote of 18 (y) - 3 (n). The naye votes included Representative Lensing, R. Olson, and Wessel-Kroeschell.

HSB 31 - Chairperson Baltimore introduced Representative Kaufmann for opening statements. Amendment 31.131 was introduced and it was passed with a unanimous voice vote. With no further discussion and closing comments by Representative Kaufmann, HSB 31 was brought to a vote. It will be passed to the House Floor as a committee bill with a vote of 21 (y) - 0 (n).

HSB 34 - Chairperson Baltimore introduced Representative Garrett for opening comments regarding HSB 34. With the introduction of Amendment 34.37 in addition to HSB 34 it was passed by a voice vote with one naye by Representative R. Olson. With no further discussion of HSB 34 it gained the constitutional majority of 20 (y) - 1 (n) with the naye being Representative R. Olson.

HSB 37 - Chairperson Baltimore introduced Representative Brandenburg for opening comments

on HSB 37. With there being no further discussion it was immediately brought a committee vote. It gained the constitutional majority of 21 (y) - 0 (n). HSB 37 as amended will be moved to the House Floor as a committee bill.

With no further business to come before the committee, Chairperson Baltimore adjourned at 1:50.
