Representative Salmon moved Amendment .37.

Amendment .37 passed unanimously with a voice vote.

Chair Baudler recognized Representative Salmon for closing remarks on HSB 53 as amended. Representative Salmon made closing remarks. Representative Salmon moved HSB 53 as amended.
