Representative Jorgensen (CH) called the meeting to order at 3:07 p.m.

Representative Jorgensen turned the chair over to Representative Stanerson.

Representative Stanerson (CH) recognized Representative Jorgensen for opening comments on HSB 4 (A study bill relating to and providing for education reform involving student, teacher, and administrator programs and activities under the purview of the department of education, the state board of education, the college student aid commission, school districts, and accredited nonpublic schools; making appropriations and providing for the establishment and retention of certain fees; and including transition and effective date provisions.). Representative Jorgensen concluded his opening comments and noted that there were amendments.

Representative Stanerson moved to defer on HSB 4, Seconded by Representative Steckman.

The motion passed without objection.

The Chair recognized Representative Winckler for opening comments on amendment HSB4.167.203. After discussion, the chair recognized Representative Winckler for closing comments on amendment HSB4.167.203. Representative Winckler moved her amendment. The amendment failed by a voice vote.

The Chair recognized Representative Hanson for opening comments on amendment HSB4.167.191. After discussion, the chair recognized Representative Hanson for closing comments on amendment HSB4.167.191. Representative Hanson moved his amendment. The amendment failed by a voice vote.

The Chair recognized Representative Wood for opening comments on amendment HSB4.167.207. After Discussion, the Chair recognized Representative Wood for closing comments on HSB4.167.207. Representative Wood moved his amendment. The amendment failed by a voice vote.

The Chair recognized Representative Staed for opening comments on amendment HSB4.167.204. After discussion, the Chair recognized Representative Staed for closing comments on HSB4.167.204. Representative Staed moved his amendment and requested a roll call vote. The amendment failed by a vote of 10 Ayes (Steckman, Abdul-Samad, Cohoon, Gaines, Hanson, Mascher, Ruff, Staed, Winckler Wood) to 13 Nays.

The Chair recognized Representative Jorgensen for opening comments on amendment HSB4.167.176. After discussion, the Chair recognized Representative Jorgensen for closing comments on amendment HSB4.167.176. Representative Jorgensen moved his amendment. The amendment was adopted by a voice vote.

The Chair recognized Representative Winckler for opening comments on amendment HSB4.167.189. After discussion, the Chair recognized Representative Winckler for closing comments on amendment HSB4.167.189. Representative Winckler moved her amendment. The amendment failed by a voice vote.

The Chair recognized Representative Steckman for opening comments on amendment HSB4.167.188. Representative Steckman withdrew amendment HSB4.167.188. After discussion, the Chair recognized Representative Jorgensen for closing comments on amendment HSB4.167.216. Representative Jorgensen moved his amendment. The amendment was adopted by a voice vote.

The Chair recognized Representative Winckler for opening comments on amendment HSB4.167.206. After discussion, the Chair recognized Representative Winckler for closing comments on amendment HSB4.167.206. Representative Winckler moved her amendment. The amendment failed by a voice vote.

Having disposed of all amendments to amendment HSB4.167, the committee was now back on consideration of amendment HSB4.167 as amended. After discussion, the Chair recognized Representative Jorgensen for closing comments on amendment HSB4.167 as amended. Representative Jorgensen moved his amendment and requested a roll call vote. The amendment was adopted with a vote of 13 ayes to 10 nays (Steckman, Abdul-Samad, Cohoon, Gaines, Hanson, Mascher, Ruff, Staed, Winckler, Wood).

HSB 4 as amended passed with a roll call vote of 13 ayes to 10 nays (Steckman, Abdul-Samad, Cohoon, Gaines, Hanson, Mascher, Ruff, Staed, Winckler, Wood). The bill will now move to the floor as a committee bill.

Representative Stanerson (CH) turned the chair back to Representative Jorgensen. As there was no other business to come before the committee, Representative Fry moved to arise.
