Bacon requested to divide the Amendment 45.298 in to two sections Section (A ) Lines 2 and 3, Section B line 2. The Chair asked for questions or comments. Seeing none the Chair moved Amendment 45.298 section (A) lines 2 and 3 by voice vote. Section A line 2 and 3 of Amendment 45.298 passed by voice vote. The Chair recognized Rep. Smith for questions on Section B line 2. The Chair asked the Dept. of Public Health to comment. The Chair recognized Rep. Hunter for comments. The Chair recognized Rep. Murphy for a question. The Chair asked the Dept. of Public Health to comment. The chair recognized Rep. Bacon for closing remarks on HSB 45.298 Section (B) Line 2. The Roll was called and the Amendment 45.298 section (B) received 19 Nays with Rep. Forristall and Rep. Stutsman excused. The Chair recognized Rep. Bacon for closing remarks on HSB 45 as amended. Roll was called and HSB 45 as amended received 19 ayes with Rep. Forristall and Rep. Stutsman excused. The bill having received a constitutional majority will move to the floor as a Committee Bill.
