Committee Bill on a roll call vote. Motion carried with 20 ayes, 0 nays, 3 absent.

Representative Brandenburg was recognized to take up HSB 115, a study bill relating to matters under the purview of the credit union division of the department of commerce, and making penalties applicable. The subcommittee report of Rep. Brandenburg, Dawson and Fisher was submitted and signed. Rep. Brandenburg gave opening comments, followed by discussion. Rep. Brandenburg gave closing remarks and Chair Cownie moved HSB 115 as a Committee Bill on a roll call vote. Motion carried with 20 ayes, 0 nays, 3 absent.
