Chairperson Baltimore recognized Representative Kaufmann for opening comments on HSB 13. Discussion was held with Representative Oldson and then Representative Kaufmann for closing comments. HSB 13 passed with the constitutional majority of 12 (y) - 8 (n). The naye's included Wolfe, Anderson, Dawson, Lensing, Oldson, Olson T., M. Smith, Wessel-Kroescheell. HSB 13 will move to the house floor as a committee bill.

Chairperson Baltimore recognized Representative Hagenow for opening comments on HSB 16. There was no further discussion to come before the committee and vote was taken. HSB 16 received the constitutional majority with the a vote of 20 (y) - 0 (n). It will move to the house floor as a committee bill.

Chairperson Baltimore recognized Representative Hagenow for opening comments on HSB 100. There was no further discussion and the bill received the constitutional majority with the vote of 20 (y) - 0 (n). HSB 100 will move to the house floor as a committee bill.

Chairperson Baltimore recognized Representative Garrett for opening comments regarding HSB 121. With no discussion to come before the committee Representative Garrett delivered his closing comments. With the vote of 18 (y) - 2 (n), HSB 121 will move to the house floor as a committee bill with the constitutional majority vote.
