Chairman Grassley recognized Representative Klein, Chairman of the subcommittee for HSB 129, for opening comments on the bill.

Rep. Klein introduced the subcommittee's findings and explained the purpose of HSB 129 and amendments 432 and 446. Chairman Grassley opened the floor for discussion. After discussion concluded, Chairman Grassley called for a voice vote on amendment 432. Voice vote passed the amendment. Chairman Grassley called for voice vote on amendment 446. Voice vote passed the amendment.

Chairman Grassley then recognized Representative Shaw. Rep. Shaw concurred with the statements of Rep. Klein and noted her support. Chairmen Grassley then recognized Rep. Klein.

After Rep. Klein finished his concluding statements, he moved for a vote. The bill was passed out as a committee bill with 22 Aye votes and no Nays with Representative Baudler being excused.
