Chairman Grassley recognized Representative Hein, Chairman of the subcommittee for HSB 171, for opening comments on the bill.

Rep. Hein introduced the subcommittee's findings and explained the purpose of HSB 171 and amendment 491. Chairman Grassley opened the floor for discussion. After discussion concluded, Chairman Grassley called for a voice vote on amendment 491. Voice vote passed the amendment.

Chairmen Grassley then recognized Rep. Hein. After Rep. Hein finished his concluding statements, he moved for a vote. The bill was passed out as a committee bill with 22 Aye votes and no Nays with Representative Baudler being excused.

Chairman Grassley recognized Representative Alons, Chairman of the subcommittee for HSB 157, for opening comments on the bill.
