Chair Representative Sands called the meeting to order at 1:01 PM.

Roll call was taken and a quorum was present.

As there were no corrections, amendments and/or deletions to the March 6th meeting minutes, they were unanimously approved.

The following bill was assigned:

HSB 205 Hagenow – Chair, Windschitl and Isenhart

HSB 205 was reassigned to: Byrnes - Chair, Windschitl and Isenhart

The committee stood at ease at 1:04 PM for both parties to caucus.

The committee reconvened at 1:39 PM .

The Chairman Sands recognized Representative Stanerson for opening remarks on HF 111. An Act exempting the sales price of all-terrain vehicles used in agricultural production from the sales and use tax. The chair recognized Representative Stanerson for Amendment 564. The amendment was moved and passed on short form. The bill as amended was moved and passed by the vote 25 Aye, 0 Nay and 0 Absent. The bill will move to the house floor as a committee file as amended.

The Chairman Sands recognized Representative Moore for opening remarks on HF 252. An Act relating to beginning farmers by modifying the agricultural assets transfer tax credit, providing a custom farming contract tax credit, and terminating the agricultural loan assistance program. The chair recognized Representative Moore for Amendment 752. The amendment was moved and passed on short form. The bill as amended was moved and passed by the vote 24 Aye, 1 Nay and 0 Absent. The nay vote was Representative Isenhart. The bill will move to the house floor as a committee file as amended.

The Chairman Sands recognized Representative Vander Linden for opening remarks on HF 235. An Act repealing a requirement that taxpayers indicate on their tax returns the presence or absence of health care coverage for their dependent children and apply for certain public health

care coverage. The bill was moved and passed by the vote 16 Aye, 9 Nay and 0 Absent. The nay votes were Representatives Oldson, Forbes, Gaskill, Isenhart, Kearns, Kelly, Prichard, Stutsman, and Thomas. The bill will move to the house floor as a committee file.

As there was no additional business to come before the committee Representative Kearns moved to adjourn at 1:52 PM.
