Chairman Sands turned the chair over to Representative Landon.

The Chairman Landon recognized Representative Sands for opening remarks on HSB 150. An Act relating to property taxation by establishing and modifying property assessment limitations, providing for commercial and industrial property tax replacement payments, making

appropriations, and including effective date.

The chair recognized Representative Prichard for Amendment 1056. The amendment was moved and failed with vote of 11 Aye and 14 Nay and 0 Absent. The Aye votes by were Representatives Oldson, Forbes, Gaskill, Isenhardt, Kearns, Kelly, Muhlbauer, Riding, Prichard, Stutsman, and Thomas. The Nay votes were by Representatives Sands, Landon, Baltimore, Byrnes, Cownie, Forristall, Grassley, Hagenow, Hein, Maxwell, Moore, Stanerson, Vander Linden and Windschitl.

The chair recognized Representative Sands for Amendment 994. The amendment was moved and passed on short form.

The bill as amended was moved and passed by the vote of 14 Aye, 11 Nay and 0 Absent. The Nay votes were Representatives Oldson, Forbes, Gaskill, Isenhardt, Kearns, Kelly, Muhlbauer, Riding, Prichard, Stutsman, and Thomas. The bill will move to the house floor as a committee file as amended.

Chairman Landon turned the chair back over to Representative Sands.

As there was no additional business to come before the committee Representative Baltimore moved to adjourn at 1:05 PM.
