Representative Soderberg reconvened the meeting at 1:51.

Representative Soderberg recognized Representative Worthan for opening remarks on [SF 442](#), a bill for an act relating to appropriations to the judicial branch. (Formerly [SSB1248](#)">[SSB 1248](#).)

Representative Soderberg recognized Representative Worthan for opening remarks on amendment 442.1675 and amendment [SF 442](#).1675.1695. Following discussion, Representative Worthan was recognized for closing comments and the amendment [SF 442](#).1675.1695, passed, short form.

Discussion returned to [SF 442](#), as amended. The Chair recognized Representative Worthan for closing remarks, and Representative Worthan moved the bill. [SF 442](#) passed as amended, 25-0. Representatives voting yes: Soderberg, Lofgren, Deyoe, Dolecheck, Drake, Fisher, Garrett, Heaton, Highfill, Huseman, Koester, Rogers, Watts, Worthan Olson, Bearinger, Dunkel, Hall, Heddens, Kajtazovic, Lundby, Murphy, Running-Marquardt, Taylor, and Winckler. With passage, [SF 442](#), as amended moves to the House floor as a senate file.

Representative Soderberg recognized Representative Highfill for opening remarks on [HF 576](#), a bill for an act relating to the Iowa finance authority and making an appropriation. (Formerly [HSB191](#)">[HSB 191](#)) Discussion followed.

Representative Soderberg recognized Representative Highfill for opening remarks on amendment [HF 576](#).1664. Following discussion, Representative Highfill was recognized for closing comments and the amendment [HF 576](#).1664, passed, short form.

The Chair recognized Representative Highfill for closing remarks, and Representative Highfill moved the bill. [HF 576](#), as amended, passed, 23-2. Representatives voting yes: Soderberg, Lofgren, Deyoe, Dolecheck, Drake, Fisher, Garrett, Heaton, Highfill, Huseman, Koester, Rogers, Watts, Worthan, Olson, Bearinger, Dunkel, Hall, Kajtazovic, Lundby, Running-Marquardt, Taylor, and Winckler.
