Representative Soderberg recognized Representative Lofgren for opening remarks on amendment 452.2086.

Representative Soderberg recognized Representative Hall for opening remarks on amendment 452.2086.2115. Discussion followed. Representative Hall was recognized for closing remarks, and moved the amendment, which failed, 11-13.
