I. Procedural Business

Call to Order. The second meeting of the 2007-2008 Legislative Council was called to order by Chairperson Murphy at 1:00 p.m., Thursday, June 12, 2008, in Room 103, State Capitol, Des Moines, Iowa. Eight of the members attended the meeting via a telecommunications connection.

Minutes of June 13, 2007, Meeting. Senator Gronstal moved that the minutes of the meeting of June 13, 2007, be approved without additions or corrections. The motion was approved by voice vote.

Consideration of Reports and Additional Business. Legislative Council actions are summarized in these minutes.

Adjournment. The meeting was adjourned at 1:47 p.m.

II. Consideration of the Report of the Fiscal Committee

Chairperson Murphy recognized Representative Oldson, who discussed the Report of the Fiscal Committee. There being no objection, the report was received and filed. A copy of the report is attached to these minutes as Attachment A.

III. Consideration of the Report of the Government Oversight Committee

Chairperson Murphy recognized Senator Dvorsky, who requested that the Report of the Government Oversight Committee be accepted. There being no objection, the report was received and filed. A copy of the report is attached to these minutes as Attachment B.

IV. Consideration of the Report of the International Relations Committee


Chairperson Murphy called the Legislative Council's attention to the Report of the International Relations Committee. There being no objection, the report was received and filed. A copy of the report is attached to these minutes as Attachment C.

V. Consideration of the Report of the Studies Committee

Chairperson Murphy recognized Senator Gronstal for the Report of the Studies Committee. Senator Gronstal stated that the report recommends approval of nine studies for the 2008 Legislative Interim, two of which are carryover studies from the 2007 Legislative Interim.

Representative Greiner moved that the Legislative Council approve establishment of an interim study committee comprised of 10 to 14 members of the General Assembly to consider the effects of the 2008 flooding on the Iowa livestock industry, including the differential effects on small and large producers, financing issues, and effects on businesses associated with the livestock industry. Furthermore, she stated, the study committee should be directed to consult with experts who can provide options to address the challenges being confronted. The motion was amended to include in the charge "the effects on commodity prices." Upon conclusion of discussion, Senator Greiner's motion, as amended, was adopted.





Senator Gronstal moved that the report, as amended, be adopted. The motion was adopted by voice vote. A copy of the report, as amended and approved by the Legislative Council, is attached to these minutes as Attachment D.

VI. Consideration of the Report of the Service Committee

Chairperson Murphy recognized Senator Gronstal for the Report of the Service Committee. Senator Gronstal explained that the report contains annual personnel reports from the Legislative Services Agency and the Office of Citizens' Aide/Ombudsman, including recommendations for promotions, exceptional meritorious increases, the reclassification of employees, and the addition and elimination of positions. The report also recommends that the Legislative Council approve the proposed budget and budget allocations for FY 2009 for the Legislative Services Agency and the Office of Citizens' Aide/Ombudsman. Senator Gronstal moved adoption of the report. The motion was adopted by voice vote. A copy of the report is attached to these minutes as Attachment E.

VII. Consideration of the Report of the Supreme Court

Chairperson Murphy recognized Mr. Richard Johnson, Legal Services Division Director, Legislative Services Agency, who stated that the Report of the Supreme Court, previously distributed, makes amendments to the Iowa Rules of Civil Procedure, the Iowa Rules of Criminal Procedure, and the Iowa Court Rules. There being no objection, the Report of the Supreme Court was received and filed.

VIII. Additional Business

Testimony of Lieutenant Governor Patty Judge. Chairperson Murphy recognized Lieutenant Governor Patty Judge, who, via telephone, briefed the members of the Legislative Council on the weather-related disaster conditions around the state. She stated that 55 counties have been declared disaster areas by Governor Culver. An open-ended presidential disaster declaration has been in place for Iowa since the Parkersburg tornado. The process for adding areas to an open-ended presidential disaster declaration is easier, she said, but the Federal Emergency Management Agency (FEMA) must first conduct an assessment. She also stated that she and the governor have had preliminary conversations with local officials on long-term disaster recovery, but the primary focus has been on the situation at hand. The governor plans to create an advisory commission on disaster recovery and long-range planning, she said.

Resolution Honoring Dennis Prouty, Director, Legislative Services Agency. Chairperson Murphy recognized Senator Gronstal to present a resolution honoring Dennis Prouty, the Director of the Legislative Services Agency. Mr. Prouty is retiring June 30 after 36 years of service to the Iowa Legislature.

Interim Appointments. Chairperson Murphy recognized Senator Gronstal, who moved that Ms. Holly Lyons, Fiscal Services Division Director, be named as an interim member of the Revenue Estimating Conference to fill the vacancy created by Mr. Prouty's retirement.

Senator Gronstal informed the Legislative Council that legislative leaders plan to appoint an interim director of the Legislative Services Agency in the near future.

Report of the International Relations Committee to the Legislative Council June 2008

Meetings: Members of the International Relations Committee of the Legislative Council met on February 26, March 29, and April 9, 2008.

Presentations and Discussion:

- **Budgets and Protocol**. The Committee discussed budgets available for gifts that members may purchase to take on official trips and the budget available for hosting international visitors at the Statehouse. Chairperson Beall and Vice Chairperson Bailey agreed to review the international visitors protocol (adopted in 2000) with the members and staff of their respective chambers.
- **Turkey Delegation**. Representatives of the Iowa Dialog Center addressed the possibility of a group of legislators visiting Turkey in summer 2008.
- United States Center for Citizen Diplomacy. Mr. Brice Oakley addressed the Committee about the status of the center, which is located in Des Moines. The center has been interested in securing state funding to combine with private and federal funds.
- **Drake University**. Dr. David Maxwell, President of Drake University, discussed Drake's two international focuses: global education, which means an international perspective that can be provided to students on campus, and international education, which means studying and experiencing life abroad. In addition, presentations were made concerning specific programs by Professor David Skidmore, Director of the Center for Global Citizenship, Ms. Gretchen Olson, Director of International Programs, Ms. Leslie Mamoorian, Associate Director of International Admissions, and Mr. Kirk Martin, Director of the Chinese Cultural Exchange Program. The colleges and universities in the state cooperate in recruiting international students.
- **Iowa State University**. Dr. Max Rothschild, Distinguished Professor of Animal Science explained that an international perspectives course is required for most majors at the university. He described the activities of the Study Abroad Center, which offers courses to prepare students to go overseas for both short-term and long-term stays, and the Volunteer Service Learning Program, which increases students' understanding that much of the world is not as well off as the United States.
- **Iowa Council for International Understanding**. Ambassador Mary Kramer explained that the council's mission is to build cultural understanding at home and abroad, one person at a time. Programs and services include translation services, serving as a conduit for international visitors, recognizing the successes and contributions of refugees, and providing assistance and counseling to families who move to central Iowa from abroad.
- Iowa Department of Economic Development (DED). Ms. Kathy Hill of the department's International Office, described trade mission activity and other departmental efforts involving other nations.
- **Thailand**. Mr. Sursee Rodari of Banker's Trust, discussed the possibility of promoting sister city and sister state relationships between Thailand and Iowa. Members discussed DED's recent approaches of developing specialized relationships between cities and states in other nations as alternatives to general ties developed under the sister state or city programs.

Report of the Studies Committee as Amended and Approved by the Legislative Council on June 12, 2008 2008 Legislative Interim Studies

A. Carryover Studies From 2007 Interim

Criminal Code Reorganization Study Committee 1.

Charge: Meet during the 2007 and 2008 Legislative Interims to consider proposals for Criminal Code revisions, reorganization, and updates.

Members: 3 Senate/3 House/8 voting public members appointed by leaders to represent each of the following: Professor from University of Iowa College of Law, Professor from Drake University Law School, district court judge, Iowa Attorney General, State Public Defender, Iowa County Attorneys Association, Iowa Board of Parole, and Department of Corrections. The Committee and its subcommittees are authorized to hold meetings outside the Des Moines area.

Meeting Days: 2 days for 2008

2. Legislative Property Tax Study Committee (2007 Iowa Acts, S.F. 601, § 127) Charge: The Legislative Property Tax Study Committee is established for the 2007 and 2008 Legislative Interims to perform a comprehensive review of the property tax system. The Study Committee may contract for analysis or other services. The cost for such contracting shall not exceed \$150,000.

Members: 5 Senate/5 House/9 nonvoting members appointed by leaders, including one nonvoting member who is engaged in economic development activities in the state/3 nonvoting executive branch agency members appointed by the Governor. Meeting Days: 2 days for 2008

B. Other Interim Studies

1. Effects of Flooding on Livestock Industry Study Committee

Charge: Consider the effects of the 2008 flooding on the lowa livestock industry, including commodity prices, differential effects on small and large producers, financing issues, and effects on businesses associated with the livestock industry. The Study Committee shall consult with experts who can provide options to address the challenges being confronted.

Members: 5 Senate/5 House Meeting Days: 2

Energy Efficiency Plans and Programs Study Committee 2.

Charge: Examine the existence and effectiveness of energy efficiency plans and programs implemented by gas and electric public utilities, with an emphasis on results achieved by current plans and programs from the demand, or customer, perspective, and make recommendations for additional requirements applicable to energy efficiency plans and programs that would improve such results. In conducting the study and developing recommendations, the Study Committee shall consider testimony from the Iowa Utilities Board, rate-regulated and nonrate-regulated gas and electric utilities, the Consumer Advocate, state agencies involved with energy efficiency program administration, environmental groups and associations, and consumers. Members: 5 Senate/5 House

Meeting Days: 2

3. Identity Theft Prevention Study Committee

Charge: Assess and review the extent to which personal, identifying information of a resident of this state is in the possession of government or government-affiliated organizations, and which, if disclosed, could render the resident vulnerable to identity theft. Also assess the extent to which public officials, government organizations, and affiliated organizations make available, are in possession of, have access to, or are disclosing or selling such information for compensation. Based upon this assessment and review, the Committee shall develop recommendations relating to these practices. **Members:** 3 Senate/3 House

Meeting Days: 1

4. Iowa Law Enforcement Academy Facility Analysis

Charge: Issue a request for proposals to contract for an independent entity to analyze and make recommendations for an optimal site and facilities for the Iowa Law Enforcement Academy. The analysis shall address the considerations necessary for relocating the academy. The cost of the analysis shall not exceed \$150,000. **Members:** 3 Senate/3 House members from the Joint Appropriations Subcommittee on the Justice System

Meeting Days: 1

5. Mass Transit Study Committee

Charge: Study the ways in which mass transit might be employed to provide public transportation services among lowa communities. Consider the ways mass transit availability affects various populations in rural and urban communities, particularly those who are unable to drive or cannot afford to own a motor vehicle; determine any impact mass transit within communities can have on population levels, quality of life, and economic development in urban job centers, small and satellite communities, and rural towns; identify the effect of mass transit on greenhouse gases and on overall air quality; determine the level of public need for mass transit, including any specific areas in immediate need; investigate the feasibility of expanding mass transit services and the types and combination of services that might comprise a state mass transit system; identify potential costs and funding mechanisms for developing and maintaining specific mass transit services; and assess the attitudes and habits of lowans concerning personal transportation and ways to educate the public about the economic, social, and environmental advantages of mass transit. Consult with the interests listed in 2008 lowa Acts, S.F. 2425, § 146, in conducting the study.

6. Medicaid Elderly Waiver Program Study Committee

Charge: Review the services, costs, and requirements under the Medicaid Home and Community-based Services Elderly Waiver Program. Consult with the Department of Human Services and persons interested in the program. Make recommendations for appropriate changes to the program.

7. Medicaid Program Drug Product Selection Study Committee

Charge: Convene public and private stakeholders to review current law for drug product selection under the Medicaid program.

8. Postsecondary Education Rigor Analysis

Charge: Issue a request for proposals to contract for an independent entity to analyze and compare the rigor of the first two years of study at community colleges and institutions of higher education governed by the State Board of Regents. Make the report of the analysis publicly available by July 1, 2009. (required by 2008 Iowa Acts, H.F. 2679, § 7)

C. Procedural Items

1. **Completion Deadline.** The previously approved deadline for completion of 2008 interim study committee meetings is December 15, 2008. An interim study committee must meet the deadline or receive an exemption or a revised deadline date from the Legislative Council. (Study Guidelines approved by the Legislative Council June 13, 2007)

2. **Membership Changes.** Any change in membership numbers and voting status of the members of a legislative interim study body approved by the Legislative Council requires the approval of the Studies Committee and Legislative Council or legislative leadership.
