Transportation Committee Meeting 2/20/14

The meeting was called to order at 10:47 A.M.

The roll was taken silently and the minutes were approved as printed.

At 10:47 A.M. the meeting was recessed until the end of party caucuses.

At 11:27 A.M. the meeting was resumed.

Senator Taylor moved [SF 335](#) passage and gave his opening comments. Chairman Bowman gave Senator Taylor permission to introduce the amendment. Senator Taylor introduced the amendment (.2662) and explained the changes. With no discussion the amendment was moved and a short form vote was called for. The amendment passed unanimously by all present members. With discussion the amended bill was moved and a record vote was called for. The bill passed with 8 Ayes, 4 Nays and 1 absent. Senators Kapucian, Behn, Breitbach and Zumbach voted no. Under Rule 40 was moved to the Senate calendar as a committee bill.

The chair recognized Senator Brase for the presentation of Senate File 2103. He gave opening remarks, after discussion from Senators Dearden, Kapucian and McCoy the bill was moved. After a short form vote, the bill passed with 8 ayes, 4 nays and 1 absent. Senators Kapucian, Behn, Breitbach and Zumbach voted no.

Senator Bowman passed the chair to Vice Chair Beall. Chairman Beall gave the floor to Senator Bowman for discussion of [SSB 3110](#). Senator Bowman moved [SSB 3110](#) passage and gave his opening comments. Chairman Beall gave Senator Bowman permission to introduce the amendments.

Senator Bowman introduced the amendment (.2753) and explained the changes. With discussion the amendment was moved and a short form vote was called for. The amendment passed unanimously by all present members.

Senator Bowman introduced the amendment (.2610) and explained the changes. With no discussion the amendment was moved and a short form vote was called for. The amendment passed unanimously by all present members.

Senator Bowman introduced the amendment (.2912) and explained the changes. With no discussion the amendment was moved and a short form vote was called for. The amendment passed unanimously by all present members.

Senator Bowman introduced the amendment (.2916) and explained the changes. With no discussion the amendment was moved and a short form vote was called for. The amendment passed unanimously by all present members.

With discussion from Senators McCoy, Kapucian and Dvorsky, the amended bill was moved and a record vote was called for. The bill passed with 9 ayes, 3 nays and 1 absent. Senators Dvorsky, Dearden and McCoy voted no. under Rule 40 was moved to the Senate calendar as a committee bill.

The chair recognized Senator Bowman for the presentation of [SSB 3136](#). He gave opening remarks, after no discussion the bill was moved. After a short form vote, the bill passed unanimously by all present members.

Senator Beall gave the chair back to Senator Bowman, and Chairman Bowman recognized Senator Beall for opening comments on [SF 2135](#). He gave opening remarks, after discussion from Senator Kapucian, the bill was moved. After a short form vote, the bill passed unanimously by all present members.

Senator Bowman passed the chair to Vice Chair Beall. Chairman Beall gave the floor to Senator Bowman for discussion of [SSB 3191](#). Senator Bowman moved [SSB 3191](#) passage and gave his opening comments. He gave opening remarks, after discussion from Senator Kapucian, the bill was moved. After a record vote, the bill passed with 11 ayes, 1 nay and 1 absent with Senator Behn voting no.

Senator Beall gave the chair back to Senator Bowman, and Chairman Bowman recognized Senator Brase for opening comments on [SSB 3192](#). He gave opening remarks, after discussion and questions from Senators McCoy, Behn, Zumbach and Dearden, the bill was moved. After a record vote, the bill passed with 10 ayes, 2 nays, and 1 absent. Senators Dearden and Dvorsky voted no.

Chairman Bowman recognized Senator Brase for opening comments on [SSB 3193](#). He gave opening remarks, after discussion from Senator Kapucian, the bill was moved. After a short form vote, the bill passed unanimously by all present members.

Senator Dearden motioned that the Department of Transportation be notified that a member of that Department should be present at all Senate Transportation meetings.

With no further business, Senator Zumbach moved we adjourn at 12:20 P.M.
