Senator Bolkcom recognized Senator Dotzler for [SSB 3016](#). Senator Dotzler requested [SSB 3016](#) be substituted with [HF 2436](#). Senator Dotzler requested passage of [HF 2436](#). Senator Dotzler requested short form vote on [HF 2436](#). The bill passed unanimously, with Senator Behn absent, and moved to calendar as a committee bill.

Senator Bolkcom recognized Senator Black for [SF 2198](#). Senator Black introduced [SF 2198](#) and requested passage. Senator Black requested short form vote on [SF 2198](#). The bill passed unanimously, with Senator Behn absent, and moved to calendar as a committee bill.

Senator Bolkcom recognized Senator Dotzler for [SF 2308](#). Senator Dotzler introduced [SF 2308](#) and distributed amendment 3184 and recommended passage of the amendment. Senator Dotzler requested short form vote on the amendment. Short form vote was taken on the amendment, passed unanimously. Senator Dotzler requested short form vote on 2308, as amended. The bill passed, as amended, unanimously, with Senator Behn absent, and moved to the calendar as a committee bill under Rule 40.

Senator Bolkcom recognized Senator Petersen for [SSB 3181](#). Senator Petersen introduced [SSB 3181](#) and requested passage. Senator Petersen requested short form vote on [SSB 3181](#). The bill passed unanimously, with Senator Behn absent, and moved to calendar as a committee bill.

Senator Bolkcom recognized Senator Hogg for [SSB 3015](#). Senator Hogg requested [SSB 3015](#) be substituted with [HF 2435](#). Senator Hogg requested passage of [HF 2435](#). Senator Hogg requested short form vote on [HF 2435](#). The bill passed unanimously, with Senator Behn absent, and moved to calendar as a committee bill.
