The committee went to caucus at 3:05 pm and returned at 3:23 pm.

Chairman Byrnes recognized Representative Jorgensen for opening comments on <u>SF 2228</u>. Representative Cohoon voiced his support of the bill. With no further discussion, Representative Jorgensen offered closing comments and moved <u>SF 2228</u>. The bill passed the committee with 19 ayes, 0 nays, and 2 absent in Representatives Pettengill and R. Olson.

Chairman Byrnes recognized Representative Rogers for opening comments on <u>SF 2288</u>. There were two amendments to the bill. Representative Heartsill offered Amendment 2234, which passed with a voice vote. Then, Representative Rogers offered Amendment 3276, which passed with a voice vote.

Representative Rogers then moved <u>SF 2288</u> as amended, and the bill passed with 19 ayes, 0 nays and 2 absent with Representatives R. Olson and Pettengill.

Chairman Byrnes recognized Representative Landon for opening comments on <u>SF 2290</u>. Representative Riding voiced his support for the bill. With no further discussion Representative Landon moved <u>SF 2290</u> and the bill passed with a vote of 19 ayes, 0 nays and 2 absent with Representatives R. Olson and Pettengill.

Chairman Byrnes recognized Representative Heartsill for opening comments on HF 2351. With no further discussion Representative Heartsill gave closing comments and moved HF 2351. The bill passed with a vote of 19 ayes, 0 nays, and 2 absent with Representatives R. Olson and Pettengill.

Chairman Byrnes recognized Vice Chairman Moore for opening comments on <u>SF 2192</u>. With no further discussion Vice Chairman Moore offered closing comments and moved <u>SF 2192</u>. The bill passed with 19 ayes, 0 nays and 2 absent with Representatives R. Olson and Pettengill. With no further business to come before the committee, Representative Riding moved to arise. The meeting was adjourned at 3:37 pm.
