Senator Bolkcom recognized Senator Seng for [HF 2273](#). Senator Seng introduced [HF 2273](#) and recommended passage. Senator Seng requested short form vote on [HF 2273](#). The bill passed unanimously, with Senators Behn and Bertrand absent, and moved to the calendar as a committee bill.

Senator Bolkcom recognized Senator Dotzler for [SF 2256](#). Senator Dotzler introduced [SF 2256](#) and distributed amendment 3301 and recommended passage of the amendment. Senator Dotzler requested short form vote on the amendment. Short form vote was taken on the amendment, passed unanimously with Senators Behn and Bertrand absent. Senator Dotzler requested short form vote on [SF 2256](#), as amended. The bill passed as amended, with Senators Behn and Bertrand absent, and moved to the calendar as a committee bill under Rule 40.

Senator Bolkcom recognized Senator Hogg for [SF 3201](#). Senator Hogg introduced [SF 3201](#) and distributed amendment 3323 and recommended passage of the amendment. Senator Hogg requested short form vote on the amendment. Short form vote was taken on the amendment, passed unanimously with Senators Behn and Bertrand absent. Senator Hogg requested short form vote on [SF 3201](#), as amended. The bill passed as amended, with Senators Behn and Bertrand absent, and moved to the calendar as a committee bill under Rule 40.

Senator Bolkcom recognized Senator Dotzler for [SSB 3162](#). Senator Dotzler introduced [SF 3162](#) and recommended passage. Senator Dotzler requested short form vote on [SF 3162](#). The bill passed with Senators Chapman and Schneider voting nay; Senators Behn, Bertrand, and Quirmbach absent. [SF 3162](#) moved to the calendar as a committee bill.
