Chair Baudler called the meeting to order at 3:00PM.

Roll call was taken and a quorum was present. Representative Muhlbauer was excused.

The minutes reviewed and approved by unanimous consent.

Chair Baudler and Ranking Member Kressig announced the caucus of their respective parties at 3:05 P.M.

The committee reconvened at 3:30 P.M.

Chair Baudler recognized Representative Klein for opening comments on [SF 2310](#): A bill for an act relating to the underage possession or consumption of alcohol and providing penalties. Representative Klein made opening comments on the bill. As there was an amendment to the bill, Chair Baudler recognized Representative Klein for consideration of Amendment 3181 to [SF 2310](#). After opening comments on the amendment, Chair Baudler recognized members of the committee for discussion on the amendment. After questions and discussion, Representative Klein moved Amendment 3181. Amendment 3181 passed unanimously with a voice vote. As there was a second amendment to the bill, Chair Baudler recognized Representative Klein for consideration of Amendment 3328 to [SF 2310](#). After opening comments on the amendment, Chair Baudler recognized members of the committee for discussion on the amendment. After questions and discussion, Representative Klein moved Amendment 3328. Amendment 3328 passed unanimously with a voice vote. These amendments will move to the floor as committee amendments. After discussion on the bill, Representative Klein moved [SF 2310](#) as amended. [SF 2310](#) as amended passed 15-5. Representatives Abdul-Samad, Anderson, Berry, Gaines, Olson, R. voted nay. Representative Muhlbauer was excused. Having received an affirmative vote of a majority of the committee membership as required to report a bill out of committee, [SF 2310](#) as amended moved to the House Floor.

As there was no additional business to come before the committee, Representative R. Olson moved to adjourn.

The meeting was adjourned at 3:40 PM.
