Chairman Sands recognized Representative Hein for opening remarks on [HSB 669](#). An Act exempting from the sales tax the sales price of a diesel fuel trailer or seed tender used primarily in agricultural production.

The chair recognized Representative Hein for Amendment 3388. The amendment was moved and passed on short form.

The bill as amended was moved and passed by the vote 23 Aye, 2 Nay and 0 Absent. The nay vote was Representatives Oldson and Isenhart. The bill will move to the house floor as a committee bill as amended.

Chairman Sands recognized Representative Windschitl for opening remarks on [HF 2198](#). An Act relating to the registration and regulation of motorsports recreational vehicles, recreational vehicle operators, and recreational vehicle cargo, and including fees.

The chair recognized Representative Windschitl for Amendment 3309. The amendment was moved and passed on short form.

The bill as amended was moved and passed by the vote 25 Aye, 0 Nay and 0 Absent. The bill will move to the house floor as a committee bill as amended.

Chairman Sands recognized Representative Landon for opening remarks on [HF 2305](#). An Act relating to the administration of programs by the economic development authority by modifying the high quality jobs program, creating a workforce housing tax incentives program and making penalties applicable, and repealing the enterprise zone program.

The chair recognized Representative Landon for Amendment 3058. The amendment was moved and passed on short form.

The bill as amended was moved and passed by the vote 25 Aye, 0 Nay and 0 Absent. The bill will move to the house floor as a committee bill as amended.
