Representative Soderberg called the Appropriations Committee to order. The Chair dispensed with roll. Minutes from the April 2, 2014, meeting were approved. The Chair assigned the following bill to the House Administration and Regulation Appropriations subcommittee:

[SF 2342](#) An act relating to and making appropriations to certain state departments, agencies, funds, and certain other entities, providing for regulatory authority, and other properly related matters, and including effective date and retroactive applicability provisions.

Both parties went to caucus at 10:05. With the meeting block schedule time expired, the committee recessed at 11:00.

Representative Soderberg reconvened the meeting at 1:10.

Representative Soderberg recognized Representative Huseman for opening remarks on [SF 2130](#), a bill for an act relating to and making transportation and other infrastructure-related appropriations to the department of transportation, including allocation and use of moneys from the road use tax fund and the primary road fund, and including effective date provisions. (Formerly [SSB 3152](#).)

Representative Soderberg recognized Representative Rogers for opening remarks on amendment 2130.3776. Following discussion, Representative Rogers was recognized for closing comments and moved the amendment on short form. The amendment passed on a voice vote.

The Chair returned the committee to [SF 2130](#), as amended. Following discussion, Representative Huseman moved the bill. [SF 2130](#) passed, 25-0. Representatives voting yes: Soderberg, Highfill, Deyoe, Dolecheck, Drake, Fisher, Gustafson, Heaton, Huseman, Koester,

Lofgren, Rogers, Watts, Worthan, Jacoby, Bearinger, Dunkel, Hall, Heddens, Lundby, Olson, Running-Marquardt, Taylor, Thede, and Winckler . With passage, [SF 2130](#), as amended, moves to the House floor as a committee bill.

The amendment passed, 25-0.
