Chair Baudler then recognized Representative Klein for consideration of Amendment 4268 to [SF 2360](#). After opening comments on the amendment, Chair Baudler recognized members of the committee for discussion on the amendment. After questions and discussion, Representative Klein moved Amendment 4268. Amendment 4268 passed with a voice vote.

Chair Baudler then recognized Representative Klein for consideration of Amendment 4299 to [SF 2360](#). After opening comments on the amendment, Chair Baudler recognized members of the committee for discussion on the amendment. After questions and discussion, Representative Klein moved Amendment 4299. Amendment 4299 passed with a voice vote.

After discussion on the bill, Representative Klein moved [SF 2360](#) as amended. [SF 2360](#) as amended passed 13-5. Representatives Brandenburg, Fry, Huseman, Rayhons and Worthan voted nay. Representatives Berry, Dawson and Sands was excused. Having received an affirmative vote of a majority of the committee membership as required to report a bill out of committee, [SF 2360](#) as amended moved to the House Floor.
