The Committee recessed for caucus at 3:18 p.m.

The Committee reconvened at 3:35 p.m.

Senator Mathis recognized Senator Bolkcom for [SF 31](#). Senator Bolkcom introduced [SF 31](#) and distributed amendment [SF 31.327](#). Senator Mathis recognized Senator Bolkcom for amendment [SF 31.327](#). Senator Bolkcom recommended passage of the amendment. Senator Bolkcom requested short form vote on the amendment. Short form vote was taken on amendment [SF 31.327](#), passed unanimously and Senator Chelgren was absent. Senator Bolkcom requested a roll call vote on [SF 31](#) as amended. The bill as amended passed with 8 ayes: Senators Mathis, Ragan, Allen, Bolkcom, Dotzler, Jochum, Taylor and Wilhelm, 4 nays: Senators Johnson, Costello, Garrett, and Segebart and 1 absent: Senator Chelgren. [SF 31](#) as amended moved to the calendar as a committee bill under Rule 40.

Senator Mathis turned the chair over to the Vice-chair Senator Ragan. Senator Ragan recognized Senator Mathis for [SSB 1165](#). Senator Mathis introduced [SSB 1165](#) and distributed amendment [SSB 1165.382](#). Senator Mathis recommended passage of the amendment. Senator Mathis requested a short form vote on the amendment. A short form vote was taken on amendment [SSB 1165.382](#) and passed unanimously. Senator Mathis requested short form vote on [SSB 1165](#) as amended. [SSB 1165](#) as amended passed unanimously with Senator Chelgren absent. [SSB 1165](#) as amended moved to the calendar as a committee bill under Rule 40.

Senator Ragan recognized Senator Mathis for [SSB 1198](#). Senator Mathis introduced [SSB 1198](#). Senator Mathis recommended passage and short form vote on [SSB 1198](#) was requested. [SSB 1198](#) passed unanimously with Senator Chelgren absent. [SSB 1198](#) moved to the calendar as a committee bill.

Senator Dotzler moved to adjourn. Meeting adjourned at 3:45 p.m.
