#### Approval of 2/23/15 Minutes

[SSB 1173](#) An Act related to absentee ballot deadlines. Amendment 1173.191 was adopted by a vote of 8 ayes, 6 nays (Bertrand, Chapman, Feenstra, Johnson, Schultz, Whitver), 1 absent. [SSB 1173](#) as amended was approved as a committee bill under rule 40 by a roll call vote of 8 ayes, 6 nays (Bertrand, Chapman, Feenstra, Johnson, Schultz, Whitver), 1 absent.

[SSB 1174](#) An Act concerning financial incentives received under a master contract established by the department of administrative services was approved as a committee bill by a vote of 14 ayes, 1 absent.

[SSB 1133](#) An Act concerning state employment hiring procedures. Amendment 1133.386 was adopted by a vote of 14 ayes, 1 absent. [SSB 1133](#) as amended was approved as a committee bill under rule 40 by a vote of 14 ayes, 1 absent.

[SSB 1123](#) An Act providing for charitable food donations to food banks and similar organizations. Amendment 1123.281 was adopted by a vote of 14 ayes, 1 absent. [SSB 1123](#) as amended was approved as a committee bill under rule 40 by a vote of 9 ayes, 5 nays (Chapman, Feenstra, Johnson, Schultz, Whitver), 1 absent.

[SSB 1130](#) An Act providing for the licensing of polysomnographic technologists and exceptions thereto, making penalties applicable, and including effective date provisions. Amendment 1130.165 was adopted by a vote of 14 ayes, 1 absent. [SSB 1130](#) as amended was approved as a committee bill under rule 40 by a vote of 14 ayes, 1 absent.

[SF 10](#) An Act requiring that a primary runoff election be held in the event of an inconclusive primary election for certain offices, and including effective date and applicability provisions was approved as a committee bill by a vote of 14 ayes, 1 absent.

[SSB 1152](#) An Act permitting electronic voter registration and including penalties and effective date provisions. Amendment 1152.219 was adopted by a vote of 14 ayes, 1 absent. [SSB 1152](#) as amended was approved as a committee bill under rule 40 by a vote of 8 ayes, 6 nays (Bertrand, Chapman, Feenstra, Johnson, Schultz, Whitver), 1 absent.
