Senator Dvorsky moved to approve the minutes of the February 16, 2015, and February 18, 2015, meetings. Approval of both sets of minutes was unanimous.

Committee members went to caucus at 3:09 PM, returning to the meeting at 3:29 PM.

Senator Quirnbach recognized Senator Mathis who made opening & closing remarks concerning [SSB 1047](#) and its associated amendment [SSB 1047.200](#). There was no discussion. A short form vote passed the amendment 12-2. Aye votes: Senators Quirnbach, Schoenjahn, Behn, Bowman, Dvorsky, Hart, Hogg, Johnson, Kinney, Mathis, Wilhelm, and Zaun. Nay votes: Sinclair and Schultz. Senator Kraayenbrink was excused.

A record vote passed [SSB 1047](#), as amended, 12-2. Aye votes: Senators Quirnbach, Schoenjahn, Behn, Bowman, Dvorsky, Hart, Hogg, Johnson, Kinney, Mathis, Wilhelm, and Zaun. Nay votes: Senators Sinclair and Schultz. Senator Kraayenbrink was excused.

Senator Quirnbach recognized Senator Mathis who made opening & closing remarks concerning [SF 161](#) and its associated amendment [SF 161.292](#). There was no discussion.

A record vote passed the amendment 10-4. Aye votes: Senators Quirnbach, Schoenjahn, Bowman, Dvorsky, Hart, Hogg, Kinney, Mathis, Wilhelm, and Zaun. Nay votes: Sinclair, Behn, Johnson, and Schultz. Senator Kraayenbrink was excused.

[SF 161](#), as amended, passed on a record vote, 10-4. Aye votes: Senators Quirnbach, Schoenjahn, Bowman, Dvorsky, Hart, Hogg, Kinney, Mathis, Wilhelm, and Zaun. Nay votes: Senators Sinclair, Behn, Johnson, and Schultz.

Senator Quirnbach handed the gavel to Senator Schoenjahn. Senator Schoenjahn recognized Senator Quirnbach who made opening and closing remarks concerning [SSB 1098](#) and its associated amendment [SSB 1098.228](#).

A short form vote passed the amendment unanimously. Senator Kraayenbrink was excused.
