HF 316 A bill for an act appropriating moneys to support soil and water conservation districts in this state, by funding secretary positions assigned to each district office.

HF 354 A bill for an act establishing a refugee family support services pilot program, making appropriations, and including effective date provisions.

HF 355 A bill for an act relating to food waste landfill diversion demonstration projects and making an appropriation.

HF 356 A bill for an act providing for a world language education pilot program and making appropriations.

Dolecheck, Chair; Mascher, R. Taylor

HF 357 A bill for an act relating to the local food and farm program fund, by making a name change and making an appropriation to the fund to support projects for the development or expansion of food hubs or farming innovation zones.

HF 398 A bill for an act relating to incidents involving pesticide drift, including by providing for reporting and testing, and making appropriations.

Deyoe, Chair; Bearinger, Worthan

HSB 177 A study bill for appropriating federal funds made available from federal block grants and other nonstate sources, allocating portions of federal block grants, and providing procedures if federal funds are more or less than anticipated or if federal block grants are more

or less than anticipated.

Rizer, Chair; Rogers, Running-Marquardt

Chair Soderberg recognized Representative Worthan for opening remarks on [HF 206](#) - A bill for an act concerning lottery games and revenue for support of veterans. (Formerly [HSB 49](#)">[HSB 49](#))

Discussion followed. The Chair recognized Representative Worthan for closing remarks, and Representative Worthan moved the bill. [HF 206](#) passed, 25-0. With passage, [HF 206](#) moves to the House floor as a committee bill.
