The meeting was called to order by the Chair, Rep. Linda Miller at 2:00 PM.

Roll was called and all were present.

The minutes from the previous meeting, February 26, 2015 were approved.

Both parties went to caucus at 2:05 PM.

The committee reconvened at 2:45 PM.

The Chair recognized Rep. Heaton for opening remarks on [HF 217](#), a bill for an act relating to limitations on licensed intermediate care facility beds in the state, Rep. Heaton introduced amendment .406 and it passed by voice vote. Following discussion of the bill, Rep. Heaton moved [HF 217](#) as amended, a roll call vote was taken. Having received 18 ayes, 3 nays, Rep. Anderson, Rep. Dawson, Rep. Sieck, [HF 217](#) as amended passed as a committee bill.

The Chair recognized Rep. Fry for opening remarks on [HF 251](#), a bill for an act relating to the transportation of persons with a substance-related disorder or a mental illness, Rep. Fry introduced amendment .593 and it passed by voice vote. Following discussion of the bill, Rep. Fry moved [HF 251](#) as amended a roll call vote was taken. Having received 21 ayes, 0 nays, [HF 251](#) as amended passed as a committee bill.

The Chair recognized Rep. Heaton for opening remarks on [HF 218](#), a bill for an act relating to telehealth and professional licensure, insurance coverage, and reimbursement under the medical assistance program, Rep. Heaton introduced amendment .616. Following discussion of the amendment there was a roll call vote, having received 13 ayes, and 8 nays, Rep. Wessel-Kroeschell, Rep. Abdul-Samad, Rep. Anderson, Rep. Brown-Powers, Rep. Dawson, Rep. Gains, Rep. Heddens, Rep. Winckler, amendment .616 passed. Following discussion of the bill, Rep. Heaton moved [HF 218](#) as amended, a roll call vote was taken. Having received 21 ayes, 0 nays, [HF 218](#) as amended passed as a committee bill.

Seeing no further business to come before the committee, Rep. Rizer moved that the meeting adjourn. The chair adjourned the meeting at 3:00 PM.
