#### Approval of 3/2/15 Minutes

[SSB 1122](#) – An Act relating to radon control and making penalties applicable. Amendment 1122.498 was adopted by a short form vote of 9 ayes, 6 nays (Bertrand, Chapman, Feenstra, Johnson, Schultz, Whitver). [SSB 1122](#) as amended was approved as a committee bill under rule 40 by a record roll call vote of 9 ayes, 6 nays (Bertrand, Chapman, Feenstra, Johnson, Schultz, Whitver).

[HF 202](#) - A bill for an act relating to licensure of retired volunteer dentists and dental hygienists, received a Do Pass recommendation by a short form vote of 15 ayes, 0 nays.

[SSB 1131](#) – A study bill for an act relating to expenditures of moneys from the E911 emergency communications fund. Amendment 1131.433 was adopted by a short form vote of 15 ayes, 0 nays. [SSB 1131](#) as amended was approved as a committee bill under rule 40 by a short form vote of 11 ayes, 3 nays (Courtney, Chapman, Whitver) and 1 present (Dvorsky).

[SSB 1155](#) – A study bill for an act relating to allowable disclosures of radon testing results. Amendment 1155.492 was adopted by short form vote of 14 ayes, 1 present (Chapman). [SSB 1155](#) as amended was approved as a committee bill under rule 40 by a short form vote of 14 ayes, 1 present (Chapman).

[SSB 1062](#) – A study bill for an act providing time off from work to attend presidential precinct caucuses and making penalties applicable. Amendment 1062.623 was adopted by a short form vote of 15 ayes, 0 nays. [SSB 1062](#) as amended was approved as a committee bill under rule 40 by a short form vote of 10 ayes, 5 nays (Chapman, Feenstra, Johnson, Schultz, Whitver).

[SSB 1215](#) – A study bill for an act related to elections administration and election officials. Amendment 1215.617 was adopted by a short form vote of 15 ayes, 0 nays. [SSB 1215](#) as amended was approved as a committee bill under rule 40 by a short form vote of 15 ayes, 0 nays.

[SSB 1170](#) - A study bill for an act providing for the creation of first-time homebuyer savings accounts in Iowa, including related individual income tax exemptions, making penalties applicable, and including effective date and applicability provisions. Amendment 1170.643 was adopted by a short form vote of 15 ayes, 0 nays. [SSB 1170](#) as amended was approved under rule 40 as a committee bill by a short form vote of 15 ayes, 0 nays.

[SSB 1065](#) - A study bill for an act relating to notice requirements for public improvement

projects conducted by governmental entities and the applicability of such requirements to the state board of regents. Amendment [SSB 1165](#).672 was adopted by a short form vote of 15 ayes, 0 nays. [SSB 1065](#) as amended was approved under rule 40 as a committee bill by a short form vote of 15 ayes, 0 nays.
