Senator Dotzler recommended passage of amendment [SSB 1021.712](#). Senator Dotzler requested short form vote on amendment [SSB 1021.712](#) and it passed unanimously. Senator Dotzler introduced and distributed amendment [SSB 1021.734](#). Senator Mathis recognized Senator Dotzler for the amendment. Senator Dotzler recommended passage of amendment [SSB 1021.734](#). Senator Dotzler requested short form vote on amendment [SSB 1021.734](#) and it passed unanimously. Senator Dotzler requested short form vote on [SSB 1021](#) as amended. The bill passed unanimously and moved to the calendar as a committee bill under Rule 40.

Senator Mathis turned the meeting over to Vice-chair, Senator Ragan. Senator Ragan recognized Senator Mathis for [SSB 1136](#). Senator Mathis introduced and distributed amendment [SSB 1136.698](#). Senator Ragan recognized Senator Mathis for the amendment. Senator Mathis recommended passage of amendment [SSB 1136.698](#). Senator Mathis requested short form vote on [SSB 1136.698](#) and it passed unanimously. Senator Mathis requested short form vote on [SSB 1136](#) as amended. The bill passed unanimously and moved to the calendar as a committee bill under Rule 40.

Senator Mathis recognized Senator Ragan for [SSB 1181](#). Senator Ragan introduced [SSB 1181](#) and distributed amendment [SSB 1181.471](#). Senator Mathis recognized Senator Ragan for the amendment. Senator Ragan recommended passage of amendment [SSB 1181.471](#). Senator Ragan requested short form vote on [SSB 118.471](#) and it passed unanimously. Senator Ragan requested short form vote on [SSB 1181](#) as amended. The bill passed unanimously and moved to the calendar as a committee bill under Rule 40.

Senator Mathis recognized Senator Jochum for [SSB 1182](#). Senator Jochum introduced [SSB](#)

[1182](#) and distributed amendment [SSB 1182.731](#). Senator Mathis recognized Senator Jochum for the amendment. Senator Jochum recommended passage of the amendment and a short form vote was requested. Amendment [SSB 1182.731](#) passed unanimously. Senator Johnson requested a roll call vote on [SSB 1182](#) as amended. The bill passed with 8 ayes: Senators Mathis, Ragan, Allen, Bolkcom, Dotzler, Jochum, Taylor and Wilhelm and 5 nays: Senators Johnson, Chelgren, Costello, Garrett, and Segebart. [SSB 1182](#) as amended moved to the calendar as a committee bill under Rule 40.

Senator Mathis turned the meeting over to Vice-chair, Senator Ragan. Senator Ragan recognized Senator Mathis for [SSB 1208](#). Senator Mathis introduced [SSB 1208](#) and distributed amendment [SSB 1208.691](#). Senator Ragan recognized Senator Mathis for the amendment. Senator Mathis recommended passage of the amendment and requested a short form vote. Amendment [SSB 1208.691](#) passed unanimously. Senator Mathis requested short form vote on [SSB 1208](#) as amended. The bill passed unanimously and moved to the calendar as a committee bill under Rule 40.

Senator Mathis recognized Senator Bolkcom for [SSB 1210](#). Senator Bolkcom introduced [SSB 1210](#) and recommended its passage. Senator Bolkcom requested short form vote on the bill. [SSB 1210](#) passed unanimously and moved to the calendar as a committee bill.

Senator Mathis recognized Senator Ragan for [SSB 1253](#). Senator Ragan introduced [SSB 1253](#) and distributed amendment [SSB 1253.717](#). Senator Mathis recognized Senator Ragan for the amendment. Senator Ragan recommended passage of the amendment and short form vote was requested. Amendment [SSB 1253.717](#) passed unanimously and moved to the calendar as a committee bill under Rule 40.

Senator Mathis recognized Senator Johnson for [SF 302](#). Senator Johnson introduced [SF 302](#) and recommended its passage. Senator Johnson requested short form vote on the bill. [SF 302](#) passed unanimously and the bill moved to the calendar as a committee bill.

Senator Segebart moved for adjournment. The meeting adjourned at 1:25 p.m.
