Chairman Sands called the meeting to order at 1:00 PM.

Roll Call was read and a quorum was present.

As there were no corrections, amendments and/or deletions to the March 31st meeting minutes, they were unanimously approved.

Chairman Sands recognized Representative L. Miller for opening remarks on [HF 443](#). An Act providing for the future repeal of the state board of tax review, providing for appeals to the director of revenue for certain tax matters and modifying the powers and duties of the director of revenue, and including effective date and applicability provisions.

The chair recognized Representative Vander Linden for Amendment 1251. The amendment was moved and passed on short form.

The bill as amended was moved and passed by the vote 24 Aye, 0 Nay and 1 Absent. The bill will move to the house floor as a Ways & Means committee bill as amended.

Chairman Sands recognized Representative Maxwell for opening remarks on [HF 486](#). An Act relating to the payment of writing fees when purchasing a combination package of hunting or fishing licenses.

The bill was moved and passed by the vote 24 Aye, 0 Nay and 1 Absent. The bill will move to the house floor as a Ways & Means committee bill.

Chairman Sands recognized Representative Grassley for opening remarks on [HF 522](#). An Act increasing the number of years that a taxpayer may claim a custom farming contract tax credit under a contract executed by the holder of agricultural land and a qualified beginning farmer, and including effective date and retroactive applicability provisions

The bill was moved and passed by the vote 24 Aye, 0 Nay and 1 Absent. The bill will move to the house floor as a Ways & Means committee bill.

As there was no additional business to come before the committee Representative Grassley moved to adjourn at 1: 44 PM.
