Chairman Sands called the meeting to order at 1:01 PM.

The meeting stood at ease for both parties to caucus at 1:02 PM.

The meeting reconvened at 1:48 PM.

Roll Call was read and a quorum was present.

As there were no corrections, amendments and/or deletions to the April 22<sup>nd</sup> meeting minutes, they were unanimously approved.

There were no bills assigned.

Chairman Sands recognized Representative Baltimore for opening remarks on [HF 556](#). An Act relating to applications for wireless communications facilities and infrastructure.

The chair recognized Representative Baltimore for Amendment 1467. The amendment was moved and passed on vote of 23 Aye, 0 Nay and 2 Absent. The Aye votes were Representatives Sands, Maxwell, Baltimore, Byrnes, Cownie, Forristall, Grassley, Hagenow, Hein, Miller, Moore, Nunn, Vander Linden, Windschitl, Jacoby, Brown-Powers, Finkenauer, Gaskill, Isenhardt, Kearns, Kelley, McConkey and Ruff. The Absent Representatives were Prichard and Steckman.

The chair recognized Representative Jacoby for Amendment 1587. The amendment was moved and failed on vote of 9 Aye, 14 Nay and 2 Absent. The Aye votes were Representatives Jacoby, Brown-Powers, Finkenauer, Gaskill, Isenhardt, Kearns, Kelley, McConkey and Ruff. The Nay votes were Representatives Sands, Maxwell, Baltimore, Byrnes, Cownie, Forristall, Grassley, Hagenow, Hein, Miller, Moore, Nunn, Vander Linden and Windschitl. The Absent Representatives were Prichard and Steckman.

The bill as amended was moved and passed by the vote 14 Aye, 9 Nay and 2 Absent. The nay votes were Representatives Brown-Powers, Finkenauer, Gaskill, Isenhardt, Kearns, Kelley, McConkey, Ruff and Vander Linden. The bill will move to the House floor as a Ways and Means Committee bill as amended.

Chairman Sands recognized Representative Nunn for opening remarks on [HF 385](#). An Act relating to the programs and duties of the economic development authority and including effective date and retroactive and other applicability provisions and other properly related matters.

The chair recognized Representative Grassley for Amendment 1577. The amendment was moved and passed on vote of 14 Aye, 9 Nay and 2 Absent. The Aye votes were Representatives Sands, Maxwell, Baltimore, Byrnes, Cownie, Forristall, Grassley, Hagenow, Hein, Miller, Moore, Nunn, Vander Linden and Windschitl. The Nay votes were Representatives Jacoby, Brown-Powers, Finkenauer, Gaskill, Isenhardt, Kearns, Kelley, McConkey and Ruff. The Absent Representatives were Prichard and Steckman.

The bill as amended was moved and passed by the vote 23 Aye, 0 Nay and 2 Absent. The bill will move to the House floor as a Ways and Means Committee bill as amended.

Chairman Sands recognized Representative Baltimore for opening remarks on [HF 555](#). An Act relating to the administration of programs by the economic development authority by creating a renewable chemical production tax credit, modifying the tax credit for investments in qualifying businesses and community-based seed capital funds, modifying the entrepreneur investment awards program, making miscellaneous changes to other economic development authority programs, and including effective date and retroactive and other applicability provisions.

The chair recognized Representative Baltimore for Amendment 1435. The amendment was moved and passed on short form.

The bill as amended was moved and passed by the vote 22 Aye, 1 Nay and 2 Absent. The nay vote was Representative Isenhardt. The bill will move to the House floor as a Ways and Means Committee bill as amended.
