Representative Gassman (CH) recognized Representative Jorgensen for opening remarks on amendment [SF 174](#).2280. After discussion, the Chair recognized Representative Jorgensen for closing remarks on the amendment. Representative Jorgensen moved [SF 174](#).2280. The amendment was adopted with a roll call vote of 13 ayes to 10 nays. (Ruff, Abdul-Samad, Brown-Powers, Cohoon, Gaines, Hanson, Mascher, Staed, Steckman, Winckler)

After discussion, the Chair recognized Representative Jorgensen for closing remarks on [SF 174](#) as amended. Representative Jorgensen moves [SF 174](#) as amended. The bill as amended passed

The bill as amended passed with a roll call vote of 13 ayes to 10 nays. (Ruff, Abdul-Samad, Brown-Powers, Cohoon, Gaines, Hanson, Mascher, Staed, Steckman, Winckler) Having received a constitutional majority, the bill will move to the floor as a Senate File amended by the House. Representative Gassman turned the chair back to Representative Jorgensen.
