The committee reconvened at 3:31 pm.

Representative Jorgensen (CH) recognized Representative Gassman for opening remarks on [HF 2034](#) (A bill for an act relating to permissible uses of supplemental aid for professional development paid to school districts and area education agencies under the state school foundation program). Representative Gassman noted that there were amendments.

The Chair recognized Representative Staed for opening remarks on amendment [HF 2034](#).2364. After discussion, the Chair recognized Representative Staed for closing remarks on amendment [HF 2034](#).2364. Representative Staed moved the amendment and requested a roll call vote. The amendment failed with a roll call vote of 10 ayes (Ruff, Abdul-Samad, Brown-Powers, Cohoon, Gaines, Hanson, Mascher, Staed, Steckman, and Winckler) to 13 nays.

The Chair recognized Representative Gassman for opening remarks on amendment [HF 2034](#).2392. After discussion, the Chair recognized Representative Gassman for closing remarks on amendment [HF 2034](#).2392. Representative Gassman moved the amendment. The amendment was adopted by a voice vote.

Having disposed of all amendments, the committee was back to consideration of [HF 2034](#) as

amended. After discussion, the Chair recognized Representative Gassman for closing remarks on [HF 2034](#) as amended. Representative Gassman moved [HF 2034](#) as amended. The bill as amended passed with a roll call vote of 13 ayes and 10 nays (Ruff, Abdul-Samad, Brown-Powers, Cohoon, Gaines, Hanson, Mascher, Staed, Steckman, and Winckler). Having received a constitutional majority, the bill will move to the floor as a committee bill.

Representative Jorgensen (CH) recognized Representative Gassman for opening remarks on [HSB 569](#) (A study bill relating to the disbursement of all Iowa opportunity scholarships). After discussion, the Chair recognized Representative Gassman for closing remarks on [HSB 569](#). Representative Gassman moved [HSB 569](#). The bill passed with a roll call vote of 23 ayes to 0 nays. Having received a constitutional majority, the bill will move to the floor as a committee bill.

As there was no other business to come before the committee, Representative Moore, T. moved to arise.

The committee adjourned at 3:56 pm.
