Representative Klein moved the bill as amended. [HF 2049](#) passed as amended as a committee bill to the house floor on a vote of 21 Ayes and 0 Nays.

Chair Baudler recognized Representative Klein for opening comments on [HSB 562](#). After discussion, Representative Klein moved the bill. [HSB 562](#) passed as a committee bill to the house floor on a vote of 12 Ayes and 9 Nays (Abdul-Samad, Anderson, Brown-Powers, Gaines, Kressig, Olson, Staed, Wessel-Kroeschell and Wolfe).

Chair Baudler recognized Representative Fisher for opening comments on [HF 2076](#). Chair Baudler then recognized Representative Fisher for Amendment 2400 to [HF 2076](#). After discussion, Amendment 2400 was adopted by voice vote. Representative Fisher moved the bill as amended. [HF 2076](#) passed as amended as a committee bill to the house floor on a vote of 12 Ayes and 9 Nays (Abdul-Samad, Anderson, Brown-Powers, Gaines, Kressig, Olson, Staed, Wessel-Kroeschell and Wolfe).
