Senator Mathis recognized Senator Wilhelm for [SSB 3066](#) Alzheimer's Awareness. Senator Wilhelm introduced [SSB 3066](#) and distributed Amendment [SSB 3066.2399](#). Senator Mathis recognized Senator Wilhelm for the Amendment [SSB 3066.2399](#). Senator Wilhelm recommended passage of the amendment. A short form vote was requested on [SSB 3066.2399](#). The amendment passed unanimously. Senator Wilhelm requested short form vote on [SF 3066](#) as amended. [SSB 3066](#) as amended passed with 9 ayes, 3 nays, and 1 absent. [SSB 3066](#) as amended moved to the calendar as a committee bill under Rule 40.
