# SSB 3109

Senator Mathis turned the meeting over to Vice Chair, Senator Ragan. Senator Ragan recognized Senator Mathis for <u>SSB 3109</u> Children's Mental Health and Well Being. Senator Mathis introduced <u>SSB 3109</u> and recommended its passage. A short form vote was requested. <u>SSB 3109</u> was approved unanimously and moved to the calendar as a committee bill.

## SSB 3036

Senator Ragan recognized Senator Mathis for <u>SSB 3036</u> Oral Contraceptive Prescriptions. Senator Mathis introduced <u>SSB 3036</u> and recommended its passage. A short form vote was requested. <u>SSB 3036</u> was approved: 9 ayes, 4 nays and 0 absent. <u>SSB 3036</u> moved to the calendar as a committee bill.

### **SSB 3072**

Senator Mathis recognized Senator Wilhelm for <u>SSB 3072</u> Iowa Department of Public Health

Modernization. Senator Wilhelm introduced <u>SSB 3072</u> and recommended its passage. A short form vote was requested. <u>SSB 3072</u> was approved unanimously and moved to the calendar as a committee bill.

# SF 2075
