[SSB 3088](#) – an act relating to the confidentiality of certain law enforcement record information (Dvorsky). Amendment 3088.2585 was moved. The motion carried by a short form vote of 15 ayes, 0 nays. [SSB 3088](#) as amended was moved. The motion carried by a short form vote of 15 ayes 0 nays and [SSB 3088](#) as amended was passed and moves to the calendar as a committee bill under rule 40.

[SSB 3147](#) – an act relating to the administration of city elections by permitting the county commissioner of elections to designate a city clerk to receive city candidate filings (Dearden). [SSB 3147](#) was moved. The motion carried by a short form vote of 15 ayes, 0 nays and [SSB 3147](#) moves to the calendar as a committee bill.

[SSB 3039](#) - an act relating to disaster aid payment authorization requirements under specified circumstances (Dvorsky). [SSB 3039](#) was moved. The motion carried by a short form vote of 15 ayes 0 nays and [SSB 3039](#) moves to the calendar as a committee bill.

[SSB 3145](#) – an act relating to the distribution and permissible expenditures of the emergency communications service surcharge and the name of the surcharge fund (Danielson) [SSB 3145](#) was moved. The motion carried by a short form vote of 15 ayes 0 nays and [SSB 3145](#) moves to the calendar as a committee bill.

[SSB 3075](#) - an act relating to voter registration by providing for the registration of eligible electors upon review of electronic records received from driver's license and nonoperator's identification card applications, and including effective date provisions (Danielson). Amendment 3075.2538 was moved. The motion carried by a short form vote of 15 ayes 0 nays. [SSB 3075](#) as amended was moved. The motion carried by a roll call vote of 9 ayes 6 nays (Bertrand, Chapman, Feenstra, Johnson, Schultz, Whitver) and [SSB 3075](#) as amended moves to the calendar as a committee bill under rule 40.
