### Bills

#### [SF 2091](#)

Senator Mathis recognized Senator Taylor for [SF 2091](#) Disclosure of Ownership and Control Information for Nonprofit Corporations. Senator Taylor introduced [SF 2091](#) and distributed Amendment [SF 2091](#).2603. Senator Taylor recommended the amendment's passage and a short form vote was requested. Amendment [SF 2091](#).2603 passed unanimously. Senator Taylor recommended passage of [SF 2091](#) as amended. Short form vote was requested. [SF 2091](#) as amended was approved unanimously and moved to the calendar as a committee bill under Rule 40.

#### [SF 2141](#)

Senator Mathis recognized Senator Taylor for [SF 2141](#) Reporting of Child Abuse. Senator Taylor introduced [SF 2141](#) and recommended its passage. Short form was requested. [SF 2141](#) was approved unanimously and moved to the calendar as a committee bill.

#### [SSB 3143](#)

Senator Mathis recognized Senator Bolkcom for [SSB 3143](#) Licensure of Genetic Counselors. Senator Bolkcom introduced [SSB 3143](#) and distributed Amendment [SSB 3143](#).2609. Senator Bolkcom recommended passage of [SSB 3143](#) as amended. Short form vote was requested. [SSB 3143](#) as amended passed unanimously and moved to the calendar as a committee bill under Rule 40.

Senator Mathis recommended passage of [SSB 3151](#) as amended. Short form vote was requested. [SSB 3151](#) as amended was approved unanimously and moved to the calendar as a committee bill under Rule 40.
