[SF 2013](#) - an act exempting African-style hair braiding from the definition of cosmetology (Danielson). Amendment 2013.2611 was moved. The motion carried by a short form vote of 15 ayes 0 nays and the amendment was adopted. Senate File 2013 as amended was moved. The motion carried and Senate File 2013 as amended passed by a short form vote of 15 ayes 0 nays and goes to the calendar as a committee bill under rule 40.

[SSB 3158](#) – an act relating to emergency response services by authorizing the establishment of benefited emergency response districts (Danielson). Amendment 3158.2648 was moved. The motion carried by a short form vote of 15 ayes, 0 nays and the amendment was adopted. [SSB 3158](#) as amended was moved. The motion carried by a short form vote of 15 ayes, 0 nays and [SSB 3158](#) as amended goes to the calendar as a committee bill under rule 40.

[SSB 3087](#) - A study bill for an act concerning investment of certain public funds in and public contracts with companies that boycott Israel (Danielson). Amendment [SSB 3087.2597](#) was moved. The motion carried by a short form vote of 15 ayes, 0 nays and the amendment was adopted. [SSB 3087](#) as amended was moved. The motion carried by a short form vote of 15 ayes, 0 nays and [SSB 3087](#) as amended moves to the calendar as a committee bill under rule 40.

[SF 2127](#) – an act concerning the establishment of a process for the debarment of a person from entering into certain state contracts with a state agency (Petersen). Amendment 2127.2642 was moved. The motion carried and the amendment was adopted by a short form vote of 15 ayes, 0 nays. [SF 2127](#) as amended was moved. The motion carried and [SF 2127](#) as amended passed by a short form vote of 15 ayes, 0 nays and moves to the calendar as a committee bill under rule 40.

[SF 2036](#) - A bill for an act relating to licensure of home food establishments by raising the ceiling on gross annual sales for a home food establishment (Bowman). [SF 2036](#) was moved. The motion carried and [SF 2036](#) passed by a short form vote of 15 ayes, 0 nays and moves to the calendar as a committee bill.

[HF 2147](#) - A bill for an act relating to absentee voting by uniformed and overseas citizens (Horn). Rule 39 was waived and [HF 2147](#) was moved. The motion carried and [HF 2147](#) passed by a short form vote of 15 ayes, 0 nays.

[SF 2202](#) - A bill for an act concerning department of administrative services procedures

regarding the designation of individuals as ineligible for state employment and sanctions for violations of competitive bidding procedures (Petersen). [SF 2202](#) was moved. The motion carried and [SF 2202](#) passed by a short form vote of 15 ayes, 0 nays and moves to the calendar as a committee bill.
