[SF 483](#) – Senator Bolkcom recognized Senator Hogg for [SF 483](#) an Act relating to an Electric or Natural Gas Vehicle Facility Tax Credit. Senator Hogg introduced [SF 483](#) and distributed an amendment [SF 483](#).3410. Senator Hogg recommended the amendment's passage and a short form vote. It was approved short form, 14-0. Senator Hogg recommended passage of [SF 483](#) as amended. Short form vote, 14-0. [SF 483](#) as amended was approved and moved to the calendar as a committee bill under Rule 40.

[SF 2033](#)">[SF 2033](#) – Senator Bolkcom recognized Senator Allen for [SF 2033](#) an Act Exempting from the Sales Tax certain Items and Services sold to a Nonprofit Human Blood Collection and Processing Establishment. Senator Allen introduced [SF 2033](#) and distributed an amendment [SF 2033](#).3137. Senator Allen recommended the amendment's passage and a short form vote. It was approved short form, 14-0. Senator Allen recommended passage of [SF 2033](#) as amended. Short form vote, 14-0. [SF 2033](#) as amended was approved and moved to the calendar as a committee bill under Rule 40.

[SF 2236](#)">[SF 2236](#) – Senator Bolkcom turned the chair over to Senator Allen. Senator Allen recognized Senator Bolkcom for [SF 2236](#) an Act relating to County Funding of Mental Health and Disability Services and the Mental Health and Disability Services Property Tax Levy. Senator Bolkcom introduced [SF 2236](#) and distributed an amendment [SF 2236](#).2934. Senator Bolkcom recommended the amendment's passage and a short form vote. It was approved short form, 14-0. Senator Bolkcom recommended passage of 2236 as amended. Short form vote, 14-0. [SF 2236](#) as amended was approved and moved to the calendar as a committee bill under Rule 40.

[HF 2445](#)">[HF 2445](#) – Senator Allen returned the chair to Senator Bolkcom. Senator Bolkcom recognized Senator Allen for [HF 2445](#) an Act Excluding certain Promotional Play Receipts from the Definition of Adjusted Gross Receipts for Purposes of the Wagering Tax on Gambling Games and relating to other matters involving Gambling Games Regulation. Senator Allen introduced [HF 2445](#) and recommended its passage in a short form vote. Short form vote, 11-3. [HF 2445](#) was approved and moved to the Senate calendar.
