The meeting was called to order.

Attendance was taken.

Minutes from the State Government committee meeting of 2/1/2017 were approved.

Amendments [SSB 1051.205](#) and [SSB.1051.192](#) were passed out to all committee members.

Senator Anderson, subcommittee chair for [SSB 1033](#), gave opening remarks. His subcommittee recommended passage to the Committee with all three signatures. Senator Bisignano commented and Senator Anderson made closing remarks.

A short form vote was taken. [SSB 1033](#) passed with 14 Senators voting Aye, 0 Senators voting Nay and 1 Senator absent.

[SSB 1033](#) moves to the calendar as a committee bill.

Senator Chapman, subcommittee chair for [SSB 1051](#), presented his subcommittee report, with two signatures, Senator Petersen rejecting.

Senator Chapman made opening remarks on Amendment 192 ([SSB 1051.192](#)). There was no discussion. Senator Chapman moved for a short form vote. [SSB 1051.192](#) passed with 14 Senators voting Aye, 0 Senators voting Nay and 1 Senator (Feenstra) absent.

Senator Chapman made opening remarks on Amendment 205 ([SSB 1051.205](#)). There was no discussion. Senator Chapman moved for a short form vote. [SSB 1051.205](#) passed with 14 Senators voting Aye, 0 Senators voting Nay and 1 Senator (Feenstra) absent.

[SSB 1051](#), as amended, was opened for discussion. Senator Bisignano commented on some of his concerns. Senator Jochum commented regarding concerns of the Fire Chief.

Senator Chapman made closing remarks on [SSB 1051](#), as amended, and called for a roll call vote.

Roll Call vote was recorded showing 11 Ayes (Smith, Chapman, Anderson, Bowman, Brown, Danielson, Dawson, Horn, Schneider, Schultz and Zaun), 3 Nays (Bisignano, Jochum and Petersen) and 1 absent (Feenstra).
