Chairman Highfill called the Local Government Committee to order at 3:00.

The meeting was called back to order at 3:43 p.m.

Chairman Highfill recognized Representative Landon for opening remarks on [HSB 92](#)—A bill for an act prohibiting counties and cities from establishing certain regulations relating to employment matters and the sale or marketing of consumer merchandise, providing for properly related matters, and including effective date provisions.

There was discussion.

Amendment 234 was presented by Representative Landon.

There was discussion.

Amendment 234 passed on a voice vote.

Amendment 226 was presented by Representative Meyer.

The amendment failed with a roll call vote of 9-12. (Aye-Staed, Gaskill, Kressig, Kurth, Lensing, Meyer, Nielsen, Thede, Wolfe. Nay-Highfill, Hager, Bloomingdale, Carlson, Deyoe, Gassman, Heartsill, Jones, Kaufmann, Landon, McKean, Sheets.)

Discussion continued on [HSB 92](#).

The meeting was called to recess at 3:58.

The meeting reconvened at 4:14.

Chairman Highfill recognized Representative Landon for closing remarks.

[HSB 92](#) passed with a vote of 12-9, moving to the house as a committee bill for consideration. (Aye-Highfill, Hager, Bloomingdale, Carlson, Deyoe, Gassman, Heartsill, Jones, Kaufmann, Landon, McKean, Sheets. Nay- Staed, Gaskill, Kressig, Kurth, Lensing, Meyer, Nielsen, Thede, Wolfe).

Chairman Highfill recognized Representative Heartsill for opening remarks on [HSB 57](#) –A bill for an act exempting co-owners of motor vehicles of deceased persons from fees related to the issuance of certificates of title.

There was discussion.

Chairman Highfill recognized Representative Heartsill for closing remarks. [HSB 57](#) passed with a unanimous roll call vote, moving to the house as a committee bill for consideration.

Chairman Highfill recognized Representative Kaufmann for opening remarks on [HSB 59](#) –A bill for an act relating to the procedures for granting a waterworks or sewer services franchise by a city.

Representative Kaufmann introduced amendment #224. The amendment passed with a voice vote. [HSB 59](#) passed with a unanimous roll call vote, moving to the house as a committee bill for consideration.

Chairman Highfill recognized Representative Sheets for opening remarks on [HF 130](#)—A bill for an act concerning the release of certain military personnel records.

[HF 130](#) passed with a vote of 20-0 with one absent, (Aye-Highfill, Hager, Staed, Bloomingdale, Carlson, Deyoe, Gaskill, Gassman, Heartsill, Jones, Kaufmann, Kressig, Kurth, Landon, Lensing, McKean, Meyer, Nielsen, Sheets, Thede. Absent-Wolfe) moving to the house as a committee bill for consideration.

With no other business to come before the committee, Representative Meyer moved to arise. Meeting was adjourned at 4:41.
