HSB 43 - Representative Mohr was recognized to take up HSB 43; A bill for an act relating to the use of child labor in laundry occupations. The subcommittee report of Reps. Mohr, Lundgren and McConkey was submitted and signed. Rep. Mohr gave opening remarks and asked permission to take up amendment 43.603. Amendment 43.603 passed on a voice vote. Discussion followed and with closing remarks Rep. Mohr moved the bill. Chair Cownie moved HSB 43, as amended, as a committee bill on a roll call vote. Motion carried with 22 ayes, 1 absent.

HSB 24 - Representative Landon was recognized to take up HSB 24; A bill for an act authorizing certain gas and electric utilities to submit certain federally required forms or reports to the Iowa utilities board in lieu of existing reporting requirements. The subcommittee report of

Reps. Landon, Mohr and Ourth was submitted and signed. Rep. Landon gave opening remarks and asked permission to take up amendment 24.531. Amendment 24.531 passed on a voice vote. Discussion followed and with closing remarks Rep. Landon moved the bill. Chair Cownie moved HSB 24, as amended, as a committee bill on a roll call vote. Motion carried with 22 ayes, 1 absent.

HSB 76 - Representative Landon was recognized to take up HSB 76; A bill for an act relating to public utilities and other infrastructure... The subcommittee report of Reps. Landon, Mohr and Ourth was submitted and signed. Rep. Landon gave opening remarks and asked permission to take up amendment 76.666. Amendment 76.666 passed on a voice vote. Discussion followed and with closing remarks Rep. Landon moved the bill. Chair Cownie moved HSB 76, as amended, as a committee bill on a roll call vote. Motion carried with 22 ayes, 1 absent.
