Chairman Fry recognized Representative R. Taylor for opening remarks on [HSB 80](#): A bill for an act relating to the public disclosure of information regarding founded child abuse involving a child fatality or near fatality.

The bill moved and passed with the vote of 20 Aye, 0 Nay, and 1 Absent. The bill will move to the House floor as a Human Resources Committee bill.

Chairman Fry recognized Representative Bergan for opening remarks on [HSB 146](#): A bill for an act including personal degradation as a form of dependent adult abuse by caretakers in facilities and programs regulated by the department of inspections and appeals.

The Chair recognized Representative Mascher for opening remarks on Amendment 146.913. The amendment was moved and passed on short form. The bill as amended was moved and

passed by the vote 20 Aye, 0 Nay, and 1 Absent. The bill will move to the House floor as a Human Resources Committee bill as amended.

Chairman Fry recognized Representative Bacon for opening remarks on [HF 276](#): A bill for an act relating to child in need of assistance and child abuse cases involving certain drugs and other substances.

The Chair recognized Representative Bacon for opening remarks on Amendment 276.773. The amendment was moved and passed on short form. The bill as amended was moved and passed by the vote 20 Aye, 0 Nay, and 1 Absent. The bill will move to the House floor as a Human Resources Committee bill as amended.

Chairman Fry recognized Representative Koester for opening remarks on [HSB 156](#): A bill for an act relating to access to and funding of certain mental health, substance abuse, and disability services.

The Chair recognized Representative Koester for opening remarks on Amendment 156.925. The chair recognized Representative Heddens for opening remarks on Amendment 156.925.947 to Amendment 156.925. The second degree amendment was moved and passed on short form. Amendment 156.925 was moved and passed as amended on short form. The bill as amended was moved and passed by the vote 20 Aye, 0 Nay, and 1 Absent. The bill will move to the House floor as a Human Resources Committee bill as amended.

Chairman Fry recognized Representative R. Taylor for opening remarks on [HSB 147](#): A bill for an act relating to background investigations of individuals employed through temporary staffing agencies with certain health care providers.

The Chair recognized Representative R. Taylor for opening remarks on Amendment 147.843. The amendment was moved and passed on short form. The bill as amended was moved and passed by the vote 20 Aye, 0 Nay, and 1 Absent. The bill will move to the House floor as a Human Resources Committee bill as amended.

Chairman Fry recognized Representative Lundgren for opening remarks on [HF 319](#): A bill for an act authorizing mental health professionals to perform certain functions relating to persons with substance-related disorders and persons with mental illness.

The bill moved and passed with the vote of 20 Aye, 0 Nay, and 1 Absent. The bill will move to the House floor as a Human Resources Committee bill.

As there was no additional business to come before the committee, Representative Moore moved to adjourn at 2:00 pm.
