With no further discussion Chairperson Baltimore recognized Representative Carlin for closing comments. The clerk called the vote 21 (aye)-0(nay)-0(absent). [HSB 127](#) passed as a committee bill.

[HSB 129](#)- Chairperson Baltimore recognized Representative Jones for opening comments. Discussion was now open. With no further discussion Chairperson Baltimore recognized Representative Jones for closing comments.
